## Spring Cleaning : Running Down Some Odds and Ends

For those of you who might not have noticed, we are still in transition here at ETVC — some of us in more ways than one!

For one thing, our computer bulletin board system and voice mail operation will be closing down when the current member year ends in May. Both services have been severely under utilized and were costing us a considerable amount to maintain.

For another, the member option of having the Channel mailed first class rather than bulk rate is also going by the boards with the end of the member year. The reason for this is self-evident: since the Channel is no longer being mailed out at anything but the first class rate, a member who pays extra for this privilege would not be receiving any additional value for their additional outlay.

Finally, Channel advertising rates are — well, changing. Our per month ad rates will remain the same as they currently are, but the yearly ad rate — which purchased space in six bi-monthly issues — is now simply a six-issue ad rate, while a full year's worth of advertising space will cost twice that. The principal here is equally simply: Back before we went monthly, a year contract bought you only six insertions. Now a year contract will buy twelve insertions, so it will cost twice as much.

We had considered changing our per month rate as well, but decided that we would wait for a while before taking that step in order to see whether it is really warranted.

This issue of the Channel also is four pages shorter than those we have been running, partially because some of our regular contributors are busy preparing for California Dreamin' at the end of the month. If you have not finalized your plans to attend this truly life-altering event, please do so now. This year's presenters and vendors will be fantastic, and the variety of seminars and panel sessions — not to mention the many opportunities to socialize — will make it a once in a lifetime experience not to be missed.

Some of our own folks will be among the presenters this year, including former ETVC President Jane Bolig, Current Vice President Leslie Bailey, Secretary Veronica Smith, and Education Co-Chairs Nancy Cupps and Juana Smith (Veronica's better half!). # SRS Examined Closely

The crowd of more than seventy that braved the rain to attend the seminar on SRS at Kimo's on February 8th is the largest ever for an ETVC Seminar. The featured speaker for this event was Dr. Eugene Schrang, who came all the way from Wisconsin at his own expense to give his presentation of the intricate details of sexual reassignment surgery. Dr. Schrang has performed this complicated surgery for hundreds of male-to-female patients ranging in age from 15 to 70 years.

Operating at the Theda Clark Medical Center in Neenah, Wisconsin, Dr. Schrang performs a number of surgical processes to bring our bodies in line with our female gender identity. He works from the top down; in a single visit to the operating room, it is possible to obtain a rhinoplasty and other facial surgery, breast augmentation, and finally the all-important genital surgery. Very few of us feel we get enough breast development from hormone treatment; to alleviate this problem, Dr. Schrang prefers to insert implants under the muscle through an incision made beneath the breasts to minimize scarring. He uses the penile inversion method for reassignment surgery; this usually requires an additional skin graft from the hip or abdomen to attain adequate depth. For the best results, electrolysis is recommended in the scrotal area before the surgery.

In his extensive slide presentation, Dr. Schrang revealed the details of his work. He also showed some botched cases performed by other doctors; these are usually more difficult to correct than it would be to start over if this is even possible.

In performing the reassignment surgery, Dr. Schrang strives to achieve three important goals. First, he seeks results that look feminine, complete with exposed mucosa like a genetic female. Next, he creates a neo-vagina with the proper shape and depth to function like a female. Finally, he takes great care to preserve all the nerves needed for sensual feeling. The sensitive glans (head of the penis) is used in the construction of a clitoris. As in genetic females, achieving orgasm is not guaranteed, but this is possible in all but a small fraction of his patients. For more authentic results, Dr. Schrang can perform a labiaplasty to construct a labia minora and a clitoral hood as a secondary procedure about three months after the initial surgery.

Because of the risk to himself and his medical staff, Dr. Schrang does not perform surgery on patients infected with hepatitis or HIV. He cautions overweight patients that their risk during the surgery is increased since the blood supply to the needed tissue is restricted. Postsurgical problems that can develop include a rectal-vaginal fistula where the wall between the two cavities breaks down, and closing of the neo-vagina, especially if adequate dilation is not performed in the months following surgery.

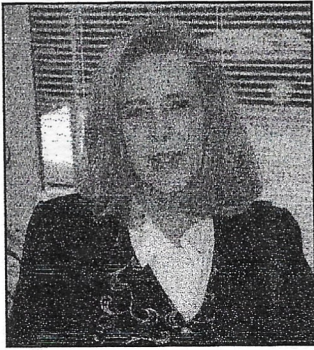

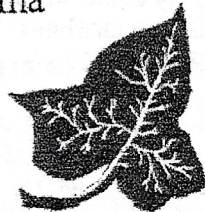

have made public transitions of their gender. The article discusses several cases of transition both from male-to-female and female-to-male subjects in a very positive light. Susan Stryker, who has addressed ETVC, and is known for her 1991 transition at UC/Berkeley, is featured in the article. Regrettably, our own Diane Giles who made a similar transition was not mentioned. The article gives an email address to request a listing of publications by transgendered scholars.


Finally, watch for a rerun of the touching "Ally McBeal" episode from late last year that featured a young transsexual played by Wilson Cruz; you probably don't remember him from the highly acclaimed but rarely watched "My So-called Life."

I hope to see all of you soon, since once you start you can't stop.

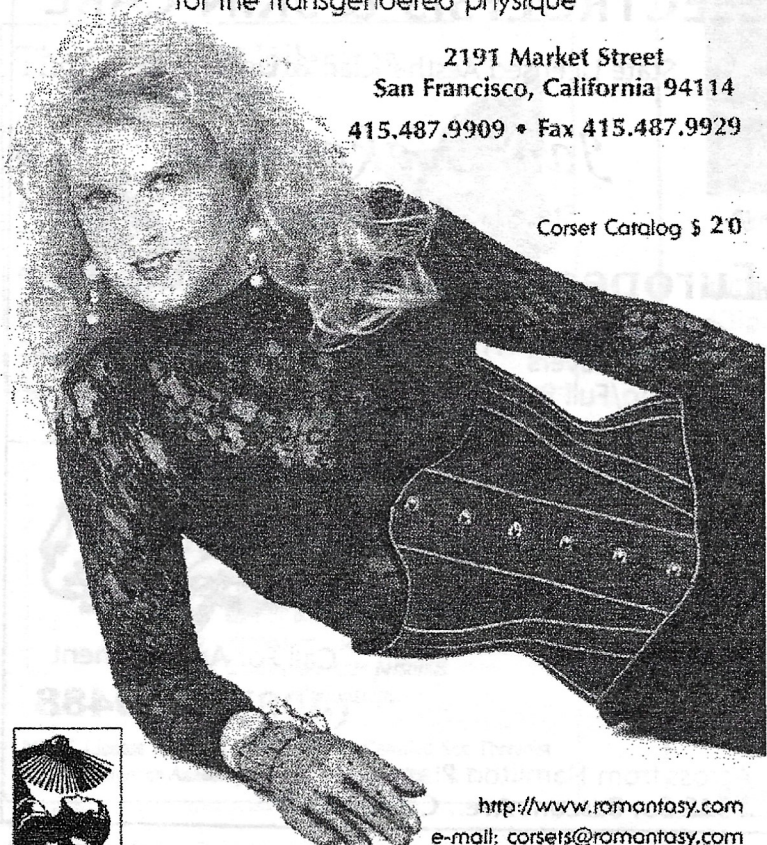

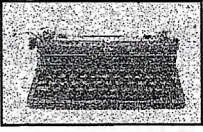

# Executive Committee Minutes

ExCom Meeting, February 8, 1998, at the Smiths. Present were President Souza, Vice President Bailey, Secretary Smith, Outreach Co-Chairs Brewer and Adams, Education Co-Chairs Cupps and Smith, and Social Co-Chair RoqueLaurie. Social Co-Chair Leopard and Treasurer Ronald were absent.

Madam President called meeting to order at 4:30 p.m. Communications and Announcements: The *Bay Times* had a good article on the Cotillion. For the Coronation on February 21, the seats are \$40 each and 9 of 10 seats are taken at ETVC's table. It was uncertain whether Empress Jose wanted ETVC representatives at Norton's gravesite on February 22. The Goodnights will be in town on the 15th. Veronica and Juana will not be able to attend.

Minutes: Evette moved January's Minutes be approved, Nancy seconded and they were unanimously approved.

President Souza congratulated Vice President Bailey and everyone connected with the Cotillion. The President was working on an analysis of Bylaw changes to be included in the ballot mailing. *Crise du jour*: In the *Bar Area Reporter* (1/22/98, p.8), Francis Vavra (Mr. ETVC '94) posted a reply to Victoria Secret's earlier letter criticizing Sandra's article (discussed in January's Minutes). Francis not only chastised Victoria Secret's perspective but also made personal critical remarks. Since Vavra signed his letter as a former Mr. ETVC, Victoria informed ETVC that the organization might be a co-defendant if she filed legal action. Victoria's attorney saw *invasion of privacy* and *defamation* as possible causes-of-action. President Souza as ETVC's official representative wrote the *B.A.R.* a letter, which stated: "ETVC neither advocates nor validates statements of a personal or private nature about second or third parties addressed therein." Erin would send Francis a letter expressing the ExCom's concern. It was also suggested that there be a stand-alone article in the April newsletter expressing ETVC's official confidentiality policy. Madam President reminded the ladies of the Executive Committee that nominations for 98-99 officers were due in March; it was time to contemplate returning or finding a successor. Erin announced that she was not going to run again for president and asked Leslie if she would consider the presidency. Leslie said that she was not particularly averse to that position, but wanted to maintain involvement with the Cotillion and Cotillion involvement was supposed to be the vice president's domain. Veronica said she would run for Secretary again if no one else wanted the position, but she would gladly acquiesce her position to whoever wanted it. Sandra would only run for Outreach Chair again with the agenda of pursuing membership, cutting giveaways (freebies). She also wanted to reevaluate the Cotillion judging criteria. However, Telzey was not enthusiastic about running again, though she'd like to serve on the Outreach Committee. Evette said that she would run for Social Chair again. Juana and Nancy said they would run for Education Chairs.

Vice President Leslie reported that the Cotillion definitely was a successful production and there seemed no

criticism. Its financials are still under review. Roughly the event cost \$9000, which was less than expected. But it looked as if it brought in only a similar amount. In other words, the Cotillion did not look like a big money loser or winner. Leslie was disappointed with the number sold to the gay contingent. Mark Klein wants to do it again next year. Leslie wants to increase attendance and get sponsor money. Erin suggested reserving the Design Center for next year. One discouraging note was that there was a theft: Jennifer had her purse taken. It was found later in the bathroom minus \$50.

Secretary: Membership is 311 of which 69 are new. Veronica briefly compared this number to last February when membership was 349 (64 new). Veronica and Juana had prepared the last *Channel 2* and sent it out. It had the November and December Minutes, updates, corrections and a request for donations for the newsletter equipment. Veronica had retyped the Bylaws to incorporate Sandra's clarifications to Veronica's clarifications of Sandra's earlier clarifications. It looked as if the Bylaws were finally done. Veronica will fit them (double-sided) on three sheets of paper. The Bylaws, Erin's analysis of them, the ballots, candidate statements, and renewal letter will be sent to the membership in mid-April. Veronica asked about a dues increase. This had often been talked about before, but not decided. Before she drafted the renewal letter, she wanted to know how much she should ask for. Evette moved that individual and singular memberships be increased by five dollars. Leslie seconded the motion and it was unanimously passed. Membership to ETVC for the 1998-1999 year will be \$30 individual and \$40 for family. Family membership does not get an extra newsletter. [6:30 p.m.]

Treasurer: In lieu of the Treasurer, Erin related the present finances. Presently the balance is \$4,140 and some forthcoming expenses are \$839 for Halloween, \$600 for tax/accounting, \$200 Cotillion scenery, \$550 Cotillion program layout. And there will be other expenses.

Education: Sarah Lashes is scheduled for March. Cal Dreamin' is in April. Closet Ball conflicts with Cal Dreamin'.

Outreach: Rather than channeling the speakers' class through the Pacific Center, Sandra wants to channel it herself and make it an ETVC function at CyberWorld, the Alternative Family Center or somewhere else. The class should last three or four hours some afternoon. Sandra wants to expand the Speakers Bureau, get Outreach on the net, and find someone to work Modesto. She and Leslie will address the Castro Lyons Club. Erin asked about the Bob Davis' suggestions about seeking TG youth. Juana suggested asking Q to invite the Digital Queers to an ETVC event. Telzey asked about the telephone number on the website.

Social: Evette reported that January's social before the Cotillion was a subdued affair with only around 25-30 attendees. Veronica was concerned that CyberWorld may eventually not welcome ETVC events if it did not make enough money. Also, at the December social, someone had walked off with the tip jar. Erin asked about whether there was going to be a *Really Big Show* this year and where would it be. Nothing was decided.

Old Business: The Standing Rules (the roles of the officers) were discussed. Veronica thought that assigning to future Secretaries the responsibility for membership, club correspondence, state filings, ExCom's Minutes, plus the newsletter production were too much for one volunteer. She did not understand why the Secretary should be responsible for the newsletter and thought that the ExCom should share that responsibility. The newsletter stuffing and mailing should be handled equally among the ExCom officers. Also, Veronica did not see why the Secretary had to write the NewsCom minutes, make copies and distribute them. The Editor always knew who was responsible for each story and, other than the ExCom, no other committee distributed minutes. The ExCom agreed that NewsCom minutes would no longer be necessary. Leslie offered to do the stuffing at her house. Since the newsletter is to be produced in the East Bay and may be copied there, perhaps it would be easier to stuff it and mail it from the East Bay as well.

New Business: Nancy Cupps showed the agreement among Elizabeth Walters, ETVC and herself (Nancy) as to the ownership of the equipment.

Adjournment: At 9:00 p.m. after 4 1/2 hours, Juana moved for adjournment, Leslie seconded, and everyone agreed to go home.

## Chapter 7: Signposts Along The Way

Seeing the film *Ma Vie En Rose* brought back a lot of childhood memories. Although I was never as open as Ludo (an early lesson quite painfully learned), I always knew that I had a female personality, and I did what I could to express myself while avoiding outright censure. Upon reflection, some of these experiences are rather bittersweet, while others are quite humorous in their naiveté. The following vignettes are just a few of the signposts I passed along my path of self-discovery and self-realization.

I got my first pair of eyeglasses when I was 10. At my next exam, the optometrist remarked upon the virtually scratch-free lenses and like-new appearance of the frames, and offered me the choice of plastic lenses – a choice that he had up until then reserved exclusively for girls. I simultaneously felt exceptionally pleased with myself and absolutely terrified by the possibility that my "secret" had been discovered. I reluctantly chose the glass lenses.

In winter, the cranberry bogs near my house froze into wonderful skating rinks. I enjoyed ice skating best when I "had" to wear my sister's white figure skates instead of a pair of "boy" hockey skates. My parents couldn't afford to buy a pair for everyone, and my brothers refused to wear "girl skates". I also

played flute in the school band during sixth grade, much to my father's open displeasure. I switched to the saxophone in seventh grade.

In seventh grade, my English class read a Willa Cather novel. In one particular passage, a young boy asks a recent mother how she knew her newborn was a girl. The reply that a girl's hair parted naturally down the middle caused me to spend quite a bit of time in front of the mirror examining my hair. Yes, I was quite naïve at the time, but I almost convinced myself that I really did have a natural center part.

Junior high school was also the time when:

\* I began carrying my books from class to class in front like the girls, and maintained that it was more practical than carrying them underarm whenever I was "challenged" by the boys.

\* My sister and I shared the in-fashion clothes (genuine "bleeding" madras shirts and a tennis sweater) the same way we shared ice skates. I loved the way the shirts buttoned right over left, and the way the tennis sweater was slightly stretched out in certain places

\* Gym class lost much of its appeal when I learned that gymnastics didn't include either the balance beam or the uneven parallel bars, and that playing field hockey was out of the question.

A particularly memorable episode of the original *Star Trek* series concerns an anthropologist that believes she was denied the opportunity to command a starship because of her gender. Upon discovering an ancient alien device that can transfer personalities between two bodies, she lures Kirk into a trap and transfers herself into his body (and vice versa). Naturally, Kirk spends the rest of the episode in a desperate attempt to reclaim himself and the *Enterprise*. What I never understood was why Kirk didn't destroy the alien device so that the anthropologist could never switch him back – I certainly would have!

Passing through adolescence and early adulthood changed nothing. When I first got cable TV, the Lifetime channel quickly became my favorite because it re-ran network shows that I had previously enjoyed, like *MacGruder and Loud*. It was three months before I learned that Lifetime's target audience was women in the 18 to 35 age bracket.

These are only a few of my experiences growing up transgendered, but they are representative of what it was like for me, a female at heart, learning to deal with the world while coping with having a male body and being pressured into a male gender role. Sometimes I wish that I had had Ludo's unwavering courage when I was younger, but we can't change the past. So, I content myself with having made my transition, and look forward to a future filled with wondrous possibilities - even though I still dread the thought of having anyone cut my hair.
