## SEMANTICS AND FEAR

While scanning all the newsletters that come to our club, I come across many semantic abuses we transgendered folk are guilty of. One common source of semantic sins, I've observed, comes from the fear many TGs have about being considered gay. For example, I read an article in which a person relates how she is feminizing herself, electrolysis, facial surgery, hormones, etc. For the most part I really liked the candid, personal narrative of self-discovery. Only I got confused when she said that her sexual identity was *bisexual* but that her sexual orientation was *heterosexual*. I understood that while her psyche was a mixture of both masculine and feminine, she was only sexually attracted to females. But I could not see how that made her heterosexual, since being heterosexual means being sexually attracted to the opposite sex. This person, I suppose, firmly believes that gender is in the soul and sex is in the genitals. But it seems somewhat grammatically convoluted to write *she* is a heterosexual who is *only attracted to women*. So why not pleasantly think of her femme self as lesbian? Or is being considered heterosexual so important to her that if she were to continue her feminization to completion, she would then no longer be attracted to women and become attracted to men?

As unlikely as that sounds, I have another example of how homophobia colors transgenderistic writing. An intelligent and sensitive person (whom I admire and personally like) once wrote that becoming attracted to men after her sexual reassignment surgery was *natural*. *Natural* seems like such an innocent word, but it is actually loaded with meaning. Its use reveals what the writer sees as inherently right and wrong, and displays personal beliefs and prejudices. To state that it is *natural* to desire a man after becoming a woman implies that it is *unnatural* for a woman to desire another woman. In other words, this person believes that for a man to take massive doses of hormones, have various invasive surgeries, restructure the face and body and *only then* have sex with a man is *natural*, but for a guy just to have sex with another guy is *not natural*.

For the two above-referenced individuals, it is paramount to be considered *straight* at all times. They would only have sex with women when they had male genitalia and they will only have sex with men when they have female genitalia. Less than 10% of their bodies determines whom they can be attracted to because they buy into their culture's homophobia. At various levels, they've accepted that being gay is wrong; at some level they supported Trent Lott when he was on the floor of the Senate quoting Leviticus and shouting something to the effect of "*The Lord sayeth only innies can do it with outies!*" They accept what certain people have gleaned from the Bible. But the Bible is many things to many people. You can use it to validate any of your prejudices. Slave owners before the Civil War used the story of Noah's children to validate slavery, and I personally remember hearing Bob Jones Jr. validate segregation with the story of the Tower of Babel. (I'm sure there are nuts out there who use the story of Lot to validate incest.) The magnetic desire of possible societal acceptance for their unusual state has them hopping, skipping and jumping around any hint that they might be considered homosexual which they have firmly accepted as socially unacceptable. But are they being completely honest with themselves? Am I the only one who finds it hard to believe that an individual who takes years to achieve complete feminization has never considered the possibility of sex with a man until the day after his/her penis has been inverted?

What must be promoted at all times is that it is just as okay to be gay as to be straight so that any conclusions are not loaded with implicit judgment. Neither homosexual nor heterosexual is more natural than the other, just as it is no more natural for some people to want to wear clothes of the opposite gender and some not, just as it is no more natural that some people are born with the wrong genitalia and some not. Not fitting within our culturally proscribed gender roles places homosexual and transgendered folks in the same family. If we don't listen to our gay brothers and sisters, our family discourse is missing essential perspectives. Vanna, in TG Forum's *Ask Rachael*, seemed to have missed just such an essential perspective. She wrote: "*I married because I thought it was the proper thing to do in society, and so people wouldn't think I was gay ... am I gay, because I've married and dated women and only thought about going with a man? Would I be normal if I dated men?*" Vanna went on to explain that she was now contemplating surgery to get her body "in line" with her mind. Rachel rightly promoted psychotherapy and suggested that Vanna may find that she is not necessarily "TS, but TG or even TV and that is okay." But I'd like to add that Vanna might very well be gay and that being gay is as okay as being TS, TG or TV and that all of the above are as okay as the other.

On the old Hollywood Squares, Peter Marshall asked Paul Lynde at what age do most American boys have their first sexual experience, and Paul Lynde responded, "About nine or ten." And then reacting to the stunned silence, Paul Lynde quickly added in his own inimitable style, "Oh! You mean their first sexual experience with *another person!* Oh well then, uh, twenty-one or twenty-two, I guess." I have no way of knowing, but I suspect that the average man's longest-term and most intimate sexual partner is himself. Doesn't this make most men at least partly homosexual? Because, I mean, you can't get much more same sex than that. But, of course, most guys would respond that it's what's in the mind that determines sexuality. But, whoa! Do we even want to go there? Because while a man's body is otherwise engaged, nearly anything can float through his head: from Sophia Loren's almond and overly made-up eyes to Demi Moore's flaunting posture and moist lips to the shine of a new ratchet set to Kathy Lee Gifford's plucky wholesomeness to Phyllis Diller's crazy cackle to Ursula

Outreach speaker requests are already pouring in for the spring semester. Many of these are from instructors who attended and thoroughly enjoyed our recent Cotillion event. I have described the event in a separate article in this issue. Nominations for TGSF officers for our next membership year are imminent. If you are ready for a change in our leadership, or if you would like to join us, now is the time to step forward.

Everyone who knows me knows I have made many friends at TGSF events over the last several years. These events are a wonderful haven for all of us to share ideas and experiences, and gain proficiency at feminine expression without exposing ourselves to the scrutiny of an often hostile public. The great majority of us know how hard it is to pass and be accepted in public even with our best effort; I think to flaunt society with an obvious dichotomy like the NBC subject only invites ridicule for himself and the rest of us. But I would welcome him at a TGSF function.

Francis makes a good point it's unfortunate support groups may not be as easy to find in remote areas. We can only hope that in time the needed support will expand everywhere; we've certainly come a long way already in recent years. All the efforts of groups such as our own help to make this happen. To be accepted in ever more remote areas we need to be seen in a positive light. Passing helps, but the most important outreach quality is to present an image that is seen as dignified when we interact with the public. Anything less will only retard our best outreach efforts.

It's unfortunate Ms Brush has decided to leave us. It's even more unfortunate our membership has dropped from over four hundred three years ago to less than three hundred today. We expect the Internet, other resources, and a more tolerant society we've at least helped to educate are some of the reasons for the decline. I too recall having some difficulty meeting people the first few times I attended ETVC events. I think two factors soon turned this around. First I made it a point to find others to share common interests with, and lastly I hung around long enough to get to know people; it's been well worth the effort.

Address coming out of the sea to your first girl friend in choir robes to draping a chamois across a shiny car to a matador twisting his body to Delta Burke's benedictional smile to Kate Moss' fragile and accepting body to Cary Grant and Eva Marie Saint appraising each other to the happy sound of champagne popping to the taste of a new lover's lips. A guy can have anything float through his head; he doesn't really have much control about that, and he can be humming *The Green Berets* at the same time. But, while men are able to eroticize anything from stiletto heels to teacups (the Victorians got worked up over piano legs), men can physically have sex with any of a multitude of things, including pillows, socks, washcloths, various fruits, even animals — Portnoy does it with the family meatloaf. So this dread some people have of even considering sex with another living human being who just happens to be the same sex puzzles me.

Frankly, I think it's crude to have genitals determine attraction. I tend to go along with writer and director David Cronenberg's ideas on the subject. "We've long ago separated ourselves from whatever biological imperative there was," he said while making *M Butterfly*. "Sexuality is an invention, it's a creative thing." What's important, I think, is to rid ourselves of the stupid prejudices and propaganda that we've all had drummed into our heads and create a sexuality with someone we trust and love regardless of gender.

## **EDUCATION SEMINAR: - CREATING A FEMININE CARRIAGE: FIGURE, POSTURE, WALK, AND GESTURE**

It is not only important for us to know how to walk like a woman, it is perhaps more important to understand from where that movement comes and why women move the way they do. When we understand that, then we are not acting, we are being. Our movement comes from within and will have a natural, relaxed quality. Walking as women do, and using feminine gestures, are first a work of creating a female shape. Women move the way they do, to an extent, because of the shape of their bodies. Creating that shape as much as possible with our bodies will not only help us move as women do but also understand why.

Our speaker, TGSF member Elaine Sagant, has been a performing dancer and dance instructor for 25 years and is certified by an international dance teachers association. It has been her vocation to analyze her clients' movement and to communicate to them what they need to do in order to move the way they want. As

a transgendered woman, Elaine's technical expertise helps her to walk her talk every day.

The most powerful tool that we have to create the shape we want is our breath. Breath gives us the awareness and strength to maintain good posture. Correct posture allows us to move the body more easily. Posture is the optimal placement of the body as a whole, the sum of all parts working together. These elements: breath, posture, shape, and movement, as well as feeling, constitute carriage. What we really want to create in a whole package is feminine carriage.

We will discuss how the common female figure differs from the common male figure, and what we can do to create a female shape for ourselves. Exercises will help us become aware of our breath and posture. We will practice various positions and movements to learn where to place and how to move the body from head to toe. You will be able to try out movements and observe your sister participants to see what you like and how movements look on each other. Movements, positions, and gestures will be verbally described and physically demonstrated. An outline of the seminar will be given to everyone. Upstairs at Kimo's, Polk & Pine Sts, SF. Donations Appreciated.

## DEAR TGSF:

After reading Francis's letter in the last newsletter (Readers Respond Feb99), I went back and read what Sandra wrote to Dateline NBC (Jan99). (I must admit, since I did not agree with Sandra's review of the show, I did not even read her article). Unfortunately, I believe this resulted in a disservice to the organization. The letter was presented at the ExCom. I do not remember if it was before it was sent or after it was sent. It was my understanding that the letter was written from Sandra to Dateline. While in the strictest sense I can see where Sandra could take the position that she was not representing the group in the letter, her opening line "As Outreach Chair for TGSF..." makes it quite easy for someone to get the impression that her opinion was representative of the group.

What bothers me more is that the message in the letter was one of division and not unity. I feel strongly that our group should be all inclusive of the greater TG community which the person in the Dateline story was obviously a member. So I will sponsor an effort to try to make sure we do not face this situation again. First I will present the following as a new standing rule at the next ExCom:

While the ExCom recognizes each member's individual right to express their own opinion, no serving ExCom member may send a document or make a statement to the public, that identifies their position on the ExCom in such a way that it might be interpreted as a statement officially made by the organization, unless the content of the document/statement has been reviewed by the ExCom and that a 2/3rd's vote of the entire ExCom (not just the one's present at the meeting) is made to approve the document or statement PRIOR to its release.

In addition I would like to write a letter to Dateline NBC, making reference to Sandra's letter and indicate that the letter was in no way representative of the group as a whole, and that several members of the group have expressed their disagreement with the views expressed in Sandra's letter. This letter would of course be presented to the ExCom subject to the standing rule mentioned above. I would like to apologize for not recognizing and responding to this situation in an appropriate manner and I would also like to thank Francis for taking the time to write his article.

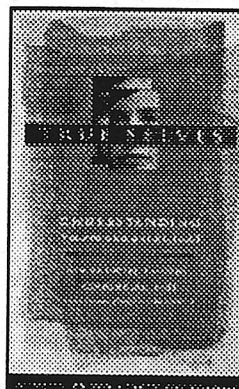

There was a birthday party for one of the TG members of the Sacramento court in the upstairs club. So after dinner we went upstairs for the show. The show was actually pretty good, sort of like the SGA talent show. We stayed at Joseph's until about 11:00 when we headed for (you should have known this was coming), yes that's right Faces. We can't go to Sacramento and not go to Faces. As usual we had a great time dancing until 1:00am or so.

What could be more tasteful than a Lingerie show, that's what I thought so that's what about 35 of our members did for the January End of Month social at the Blue Muse. Joyce of Joyce's Perfect Fit provided the outfits (except for one, the black teddy that I wore last, was purchased by me while I was trying on outfits at Joyce's a few weeks before the show). Five models participated in the show, Leslie, Lulu, Tianna, Didi and myself. At one point The Outrageous Miss Didi took her show up front, I'm not sure what she was doing but it was causing quite a bit of response. A number of very nice outfits were modeled and Joyce had a number of other items available for sale in the back of the room. In addition, Joyce brought in a rack of discontinued items each for \$5.00. Needless to say there was allot of interest in this rack after the show.

I think something happened on February 6th, oh yes the Cotillion. I would like to give a review of the Cotillion, but all I could talk about is the events in the Cotillion Kitchen. Actually we did see the last hour or so of the show. We had a few Blue Hawaiians and were floating by the end of the show. I then performed a 30 minute dress and makeup session, one of my fastest ever. then at sometime near 10:30 I sat in my chair and was able to watch the end of the show. Once again I would like to thank the volunteers (there were two I did not mention, both were working with Chelsea, I think one of them was Teri, I apologize for not remembering who the other volunteer was).

The last event to report on is the February Mid Month on the 10th at the Coco Club. About 15 or so girls showed up for some live Jazz music at this underground club. Our first and second runner's up from the Miss TGSF show were both present (Serena and Tianna). I also saw Rachael, Lulu, Janis and Everette. ## SECRETARY VERONICA'S LAST CALL FOR OFFICERS

I have to mail the ballot for the April 29th election by March 15. If you are interested in running for any office, please read the general descriptions below. Then send me a short statement and photo (either through snail mail or e-mail) so I can include you on the ballot. I want to emphasize that the below descriptions are very general and the ExCom is in the process of rewriting the officers' duties. Also, each new officer tends to customize her office to suit her strengths and more senior officers always assist the new officers. It should be noted that much of the ExCom's business is now conducted on-line, so it would be helpful if each officer had access to e-mail.

While I'm about it, I'd just like to respond very briefly to a letter of complaint that was printed in the last newsletter. You only get out of an organization what you put in it. Showing up at a social is a great first step, but it's only a first step. If you simply show up and expect all your needs to be taken care of, you'll be disappointed. If you want to meet people and to feel as if you are engaged in the life of the club, then you have to help on a project, join a committee, or run for office. In other words, you have to get engaged in the life of the club. ExCom officers are sometimes criticized for not greeting every single person and making that person feel as if she is the absolute center of the universe. Well, we try. But, you know, we all work full-time jobs. We have families and obligations. We do all the club's business on our own time and cost. One night out of the entire month we like to get dressed up and party with our friends. This is not being cliquish; it's being human. If you think it could be different, don't run away. Run for office! Don't get mad. Get elected!

The **President** is the chief administrator and is responsible for maintaining TGSF's operational integrity. Her duties include (1) chairing ExCom meetings; (2) conducting business affairs at membership meetings; (3) ensuring good communications among all the officers; and (4) serving as liaison with other organizations.

The **Vice-President** is the second in charge. Her duties are: (1) assisting the President in ensuring good communications among the officers; (2) assisting the President with managing the organization; (3) coordinating the efforts of the committees, especially Pride Parade and Cotillion; and (4) proposing a budget to the Treasurer for the fiscal year.

The **Secretary** is the general conduit of information between the ExCom and the members. Her duties are: (1) maintaining the membership list and club records; (2) documenting ExCom meetings; (3) presenting the minutes to the membership; (4) producing and distributing a newsletter to keep the members abreast of the organization's status and activity; and (5) proposing a budget for mailing and newsletter costs to the Treasurer for the fiscal year.

The **Treasurer** is the chief financial officer of TGSF. Her duties are: (1) maintaining a checking account and, if appropriate, a savings account; (2) paying TGSF's bills and collecting monies due; (3) reporting on TGSF's financial situation at each ExCom meeting, with the statistics printed in the newsletter each month; and (4) presenting a financial report for the past year and proposing a budget for the next year at the Annual Meeting.

The **Chair of the Outreach Committee** is responsible for areas of publicity, advertising, speaking forums and educating the general public. Nothing is as personal and individual as one's gender identity, but changing from one gender identity to another when you're intimately involved with someone is definitely not a solitary pursuit! The purpose of the course is to allow couples or family groups (or others in a close relationship) to explore together what one partner's gender transition means or might mean to each of them. The goal is to create a team approach to the transition, one that takes into account the relationship as well as everyone's individual needs and feelings.

This course will provide a safe place for those who are or are considering gender-transitioning and their loved ones to explore jointly the issues involved. Through group discussions, pair/triad work, worksheets, journaling, and readings, we will help each pair/group:

- Identify their hopes, fears, griefs, and uncertainties;
- Identify and solve the issues/decisions they face;
- Approach those issues/decisions as a problem-solving team.

Although participants' specific needs will set the ultimate agenda, issues likely to be discussed include: sexual orientation identity; timing of transition steps; emotional support needs; coming-out; money; body image; employment; community/friends; sexuality; legal issues; children; and sex roles.

This class will not substitute for individual or couples therapy, nor will we cover basic medical or legal transition information. Instead, the focus is on managing relationship issues before and during transition.

Both/all members of a partnership/ relationship are strongly urged to register and attend classes together. However, those whose significant other(s) are unable or refuse to attend are also welcome.

Loree Cook-Daniels and her partner Marcelle have been together 15 years, 3 of them post-transition. Loree is the national SOFFA (significant others, friends, family, and allies) coordinator for American Boyz, an F2M and SOFFA organization, and is the author of "Trans-Positioned", an article about the Lesbian-identified partners of female-to-male (FTM) transsexuals. She holds an MS in conflict management and has written, taught, and consulted on conflict analysis and resolution issues for twelve years.

## AN APPEAL FOR HELP

[QUILL-CA] High school student Adam Colton wears the cuts and bruises of a solid beating. They mark his face, his chest, his abdomen, his back. And carved into his flesh with a pen is the word "fag."

The 17-year-old was targeted for the second time this school year, the same year he decided to reveal that he is gay and formed the Gay-Straight Alliance at San Marin High School in Novato. City police are investigating the attack as a possible hate crime, said Sgt. Jim Laveroni.

Colton has no memory of the assault. Though he doesn't remember driving to school, Colton said police found his locked car in its parking lot, "which makes it a strong possibility that I was beaten up on campus," he said. Colton, a senior, wandered into a classroom after the attack, saying something about having been followed, other students have said. Then he passed out. The next thing Colton knew, he was lying in a hospital bed. He's now at home recovering.

"When I woke up in the hospital, the first thing I thought was that I'd had a diabetic emergency or was in a car accident," Colton said Saturday. "Yesterday as a whole was pretty cloudy for me." School Principal Rudy Tassano was out of town and could not be reached for comment.

The day of the first attack, on Sept. 15, someone had taken several napkins, spread them on the hood of his car parked in the school's lot, and written an obscene message in ketchup, Colton said. Early that evening, he was grocery shopping for his parents. A group of three high school teens approached him, taunting him with anti-gay epithets. He went inside and did his shopping. When he came back out, the teens jumped him.

The next week, he said, his car got keyed. The week after that, there was another ketchup message on his car. That weekend, someone wrote an epithet in lighter fluid on his family's driveway and tried to ignite it. Then there were the looks and the taunts at school, the kids who would pass him in the hall and make a hateful comment to their friends, loud enough for Colton to hear, about gays.

The pressure was exhausting. "I love going to school, but I was really starting to hate it," Colton said. Friday's assault occurred almost a year after a group of San Marin students allegedly yelled a racial epithet at some black players from nearby Tamalpais High. Three were suspended and one charged with disturbing the peace.

When he decided to come out of the closet at San Marin, Colton said, several people asked him why he would chance violence against himself. "I didn't want to keep it inside anymore," Colton said.

### Please Help

It's too late to help Matthew Shepard, but it's not too late yet to help Adam Colton. Seventeen year old Colton was courageous enough to start a gay student group at San Marin High School in Novato, California. Since then he has been physically attacked twice. Adam was found dazed and bleeding on the school grounds. He has been unable to remember who attacked him, and there were no witnesses. He suffered facial injuries in this beating, but was able to be released from the hospital after several hours treatment.

In September Adam was attacked and beaten in the parking lot of a supermarket by three teens who yelled anti-gay remarks as they beat him to the ground. At that time the police said that they were concerned for his safety and promised to do what they could. His attackers were never identified.

Adam seems to be getting discouraged. He says now that he wants to leave San Marin High. The townspeople seem supportive towards him, with the mayor of the town taking a strong stance against hate crimes, and the police with the support of the Chamber of Commerce and various residents are offering a \$7,000 reward for information leading to the arrests of the assailants.

This is a scared, frightened young man. Let's let him know that people do care. Send him a card or letter of support. Mail it to him in care of his high school. A flood of support mail just might make the school a little more aware that people care, too.

And spread the word about Adam's attack. This is not an isolated incident. Young people all over our country go through these kinds of things all the time just because they are perceived to be gay. All children deserve to be safe in their schools. Write to: Adam Colton, C/O San Marin High School, 15 San Marin Drive, Novato, CA 94945.

I'd suggest everyone contact their local papers - just call up the main number and ask for the news room and/or news editor - and ask them to report on this story. It's on the Associated Press wire now, and there's no reason why local press shouldn't be writing about it. By the way, journalist friends of mine highly recommend this strategy - they say people would be surprised as to how much newspapers listen when you call up and tell them what kind of news you'd like to see covered.

In addition, why not write an email letter-to-the-editor to your local paper about this incident. You could simply express outrage or grief - you could call for a federal hate crimes law - or you could urge local schools and public officials to do more to counter anti-gay violence and discrimination. ## WEBSITE MEMORIALIZES TRANS DEAD

All Rita Hester wanted to do was live her life just like any other woman. When Hester, a transgendered woman who lived in Boston, was found murdered by multiple stab wounds in her own apartment late last November, this was more than Gwen Smith, another woman living across the country, could bear. Ms. Smith, a professional Web designer living in the San Francisco Bay Area, did not want to do a project relating to violence and prejudice against transgendered individuals. She had to.

Ms. Smith's desire for justice led to her creation of the "Remembering Our Dead" website, a memorial to individuals killed for the simple "crime" of trying to be oneself. For example, 9-year-old Steven Wilson, taunted for playing with "girl's toys," who was raped and drowned by a neighbor child. Or Tyra Hunter, taunted with racial and transphobic slurs and neglected by emergency personnel, who died from inadequate medical care. Or Debra Forte, who suffered multiple six-inch stab wounds to the chest, any one of which would have been sufficient to kill her. As Ms. Smith notes, "When one looks at how many transpeople are murdered, and considers how much complacency there is towards these murders, one realizes that something needs to be done."

There have been seven documented trans murders since August of last year.

- Luana (Junior da Silva Lago) - August 4, 1998
- Fitzroy Green - August 22, 1998
- Monique Thomas - September 11, 1998 (estimated)
- Chanel Chandler - September 20, 1998
- Rita Hester - November 28, 1998
- Lauryn Paige - January 9, 1999
- Steve Dwayne Garcia - February 6, 1999

One is too many.

Currently, the stories on the website date back as early as 1969, and as recent as February 6th, 1999. With a reported 60% of transgender individuals having been the victim of a violent assault, it is doubtful that this site will stop growing anytime soon. Hopefully, through public education and awareness, this issue will receive the attention it deserves, along with more well-publicized accounts such as the murder of Matthew Shepard.

## P-FLAG PUSHES FRANK AND KENNEDY FOR TG INCLUSION IN ENDA

PFLAG's membership voted in the fall to become inclusive of transgendered people and family members and friends. We are firmly committed as an organization to securing the basic civil rights of transgendered persons, as well as those of our lesbian, gay and bisexual loved ones.

We encourage you to assist now in efforts to persuade Senator Kennedy and Representative Frank to include transgendered people in the version of the Employment Non-Discrimination Act (ENDA) coming up before the 106th Congress. Because the impeachment hearings have virtually stopped other business, now is the time to write letters and make calls to their offices to make our case. A letter from PFLAG National President, Paul Beeman, and Executive Director, Kirsten Kingdon, will soon go out to Kennedy and Frank encouraging them to include transgender people in ENDA.

Here are their addresses, phone numbers and key talking points:

The Honorable Edward Kennedy, Senator from Massachusetts, United States Senate, Washington D.C. 20510. 202/224-4543.

The Honorable Barney Frank, Representative from Massachusetts - 4th District, United States House of Representatives, Washington D.C. 20510. 202/225-5931.

Consider having a letter writing party at your next chapter meeting. Volume of letters makes a difference! Handwritten letters are the most effective. Talking points for calls and letters designed to address possible concerns and objections to TG inclusion. Please adapt into your own words:

- Please include transgender people in ENDA. Transgendered people face widespread discrimination in our society and as parents, families and friends of lesbian, gay, bisexual and transgendered people we cannot advocate for some of our loved ones, but not others. We are also concerned that unless gender identity is covered in civil rights legislation, lesbian, gay and bisexual people, as well as heterosexual people, who do not conform to traditional gender norms may not be protected under ENDA as currently written.
- Non-discrimination policies around the country are beginning to recognize the importance of transgender inclusion. Examples of this include our PFLAG chapter in New Orleans, Louisiana, which took a leadership role in getting an ordinance passed last summer adding gender identification to that city's non-discrimination and intimidation laws. The State of California has since amended their hate crimes statute to recognize transgendered people as a protected class. Last December, Portland, Oregon's City Council unanimously approved a resolution to take specific steps to prohibit discrimination based on "gender identity" within its work force.

## Your Advice Needed

# TRANSGENDERED PEOPLE - THE ONES WE LEFT BEHIND

We need your advice on a legislative matter. The transgendered portion of the L/G/B/T community has been left far behind the rest of us in the struggle to gain full rights and respect in our nation. Table I graphically illustrates this fact.

### Table I - The Road To Freedom

1960 Gay sex illegal in virtually all states and the District of Columbia. Several states ban the serving of alcohol to known homosexuals. Lesbians, gays, bisexuals, and transgendered people regularly arrested and, sometimes, beaten, by police for simply gathering together. No laws prohibit sexual orientation or gender identity based discrimination.

1966 City of San Diego bans cross dressing.

1969 The Stonewall riots in New York City signal the beginning of the modern "gay rights" movement.

1972 California legislature passes legislation legalizing gay sex between consenting adults in private.

1979 California Supreme Court bans employment discrimination against lesbians and gays. Transgendered people not protected by the decision.

1979 Governor Brown issues executive order banning sexual orientation based discrimination in California government. Transgendered people not covered.

1985/86? California's legislature enacts the Supreme Courts' 1979 decision into law, making the protections of that decision more secure. Transgendered people still not covered. Protections for lesbians, gays, and bisexuals are weak.

1989 California legislature passes Hate Crimes Statistics Act requiring the reporting and counting of sexual orientation based hate crimes. Transgendered people not covered.

1990 Congress passes Federal Hate Crimes Statistics Act requiring the reporting and counting of sexual orientation based hate crimes. Transgendered persons not covered.

1998 California enacts legislation providing enhanced penalties for hate crimes against transgendered people and requiring the counting and reporting of such crimes.

1999 10 States, including California, and 50 cities and counties ban sexual orientation based employment discrimination in private industry. No states and just a few cities ban employment discrimination against transgendered people.

9 states and 30 cities and counties ban sexual orientation discrimination against their own government employees and just a few cities ban employment discrimination against transgendered people in government.

According to the Human Rights Campaign, 320 "Fortune 500" corporations offer sexual orientation protection as part of their personnel policies. Just a few companies provide similar protection for transgendered people.

San Diego still bans cross dressing by transgendered people.

The election of a moderate Democrat to the Governorship of California, raises the possibility of enacting laws which would significantly advance the rights of lesbians and gays in our state. Several bills are being introduced in the state legislature to do just that. Unfortunately, transgendered people may again be left in the dust.

The current ban on sexual orientation discrimination in California is weak. The ban could be strengthened by adding the it to the California Fair Employment and Housing Act (FEHA).

At a December 5th meeting of the new statewide lobbying group, CAPE, a majority of the CAPE members present voted to support legislation to add protections for lesbians, gays, bisexuals, and transgendered people to the FEHA. However, respected legislative staffers, who have done much of great value for our community, cautioned that Governor Davis is a moderate and that adding transgendered people to a FEHA bill would probably kill it. At this point it appears that no legislator is willing to introduce a bill that adds transgendered people to the FEHA.


The issue we face is when is it time for us to risk our political capital to bring the transgendered community along with the rest of us. I'm not sure anyone knows the right answer. Should Lambda Letters forcefully advocate for the inclusion of transgendered people to any bill providing FEHA protections for lesbians and gays? If it did so, and the bill failed for that reason, there would be a lot of people angry at us. Should Lambda Letters support separate legislation to add transgendered people to FEHA? That legislation seems less likely to pass on its own. Should we simply wait until lesbians and gays are added to FEHA - hopefully in 1999 - and then put the full force of the community behind a bill for transgendered people?
