OK, gloves are off, let's get down to the nitty gritty...

Has anyone but me noticed that we haven't had an Education Seminar since last October? And as of the April ExCom meeting, there are none firmly scheduled for this month or beyond. It wasn't that long ago that we had one every month like clockwork, even two seminars a month when the TS Seminars project was in effect (alas, a noble but short-lived endeavor). But now? Nada. And the community scuttlebutt I hear is bearing this up. Well this is my last article as President of TGSF (unless I get elected to the position in some future election). I have had a good time as President and it really has been a pleasure working with the outgoing Executive Committee.

While my three-year period of service to TGSF on the Executive Committee is coming to an end, my participation in efforts to assist the Transgender community is not. You still have the opportunity to work with me to improve the Transgender experience. I am currently one of the leaders of the Employment Work Group of the San Francisco TransGender Civil Rights Implementation Task Force (SFTGCRITF), this is a duty I share with Mr. Stacy Jackson a very capable and committed individual. As always we can use your help. Helping the employment work group or one of the other four work groups of the SFTGCRITF is your opportunity to really make a difference for the TG community. You can do work for the task force dressed in whatever gender role you feel comfortable in. Keep in mind that what we do in San Francisco becomes a model for policies and legislation throughout the country.

In addition to my work for the SFTGCRITF, Debbie and I will be attending the GenderPAC conference in Washington DC this month (May) on the 18th, 19th, 20th and the gender lobby days on the 21st and 22nd. Based on my experience at the conference, I may decide to become a GenderPAC representative for the Northern California area. I do have an interest in making things happen at the State and Federal level, and I am looking for a way to become more involved in those efforts. So you may end up hearing from me with regards to this effort as well.

Some people have asked me why I elected not to run for President again this year and I wanted to say a bit about that. While there were a few issues that effected my decision, the most significant one was my concern that the organization (TGSF) should stay unified. Some of you may know that Debbie and I became more active in SGA (Sacramento Gender Association) after a difference of opinion on how the group should be run nearly split the group apart. SGA had been such a great place to go, and we met so many great people there, we did not want to see it get broken up.

It would be great if all the TG groups only had members who could see past their differences and work to make the group better. And in many instances this is the case (certainly, our last Executive Committee, and SGA's last Board of Directors is an example of that). Sometimes there are people who think things should be done differently and there is nothing wrong with that. Unfortun-

fortunate that they were members with the means to do so! I've complained in this column before about the extravagant expense and effort surrounding the Cotillion, only to watch it balloon into the financial quagmire it is today. And now that neither of the Cooks have run for another term on the ExCom, who's going to bail the group out on the next Cotillion? Take a look at the meeting minutes - if TGSF paid off the remaining 2001 Cotillion debt right now, it would go broke. Obviously it's being deferred until membership renewals come in. But do you really think your meager thirty dollars a year is going to fund the 2002 show? Think again.

Victims Or Showgirls...

That's right, and I for one am certainly neither! But that's how we're portrayed in the media and on the news. It's either Remember Our Dead, or another nightly showing of Lipsynch And Wiggle at the local watering hole, of which the Cotillion is just a puffed up and polished variation on the theme. And a lot of TS's in this town are disillusioned with the indifferent, blinkers-on attitude that TGSF members seem to have adopted lately. And I'm not talking about the one's who hold a seat on the ExCom or who appear somewhat regularly in this newsletter. I'm talking about those of you lurking on the perimeter, the ones who pay your dues, live vicariously through the media and keep your closet well stocked and tidy. You know...sheep...the flock.

We've got terrific people in this organization. Bright, shining lights in the murky bog of our community. People like Theresa Sparks - the *first ever* transgender to be appointed to San Francisco's Human Rights Commission - are fighting to dispel those images and running into walls of apathy from the very community she's fighting for. She recently posted to the TGSF e-group list asking for a show of support for St. Luke's Hospital. Our own resident Diva, Tianna deVil, transitioned there as a nurse and has since even been promoted. They are one, if not the only hospital in SF, with an employee transsexual transition policy (that Tianna helped formulate by the way). Theresa's reasoning was that if we can keep St. Luke's open, and get the affiliation with Sutter Health finished, we then will be able to go to the other nine Sutter hospitals and get transition policies instituted. Theresa is trying to effect real, positive changes in the quality of transsexuals' lives. But not one of you bothered to fax a letter of support. I mean, why would you, right? You're just a crossdresser - transition policies in the workplace got nothing to do with you, so why should you care? Certainly, as an organization, TGSF has valiantly tried to present you with opportunities to participate - just read Dana River's letter on Page 10. The question is, will you actually do anything about it? (Oh, I can sense the hate mail coming now!)

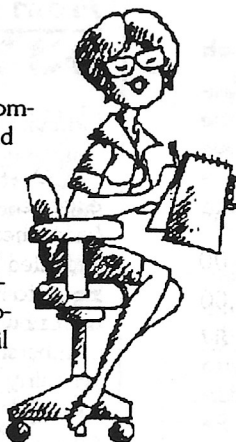
We're Broke?...

Well...I'd say we're pretty darn close to going into the red. I received the Member of the Year Award in 1998-99 because I sold over \$8,000 in advertising that year while trimming newsletter production costs by 30%. And TGSF has been living off that fat for the last two years. But that money's dried up now. As you know, I left the area and couldn't keep up the ad sales. Seriously, it only took an hour of my time each day to make some phone calls to our advertisers. And if I sold a six-month or a year contract, then I wouldn't have to call them again until they were up for renewal. It only took a couple months to get the ball rolling and after that it was pretty much self-sustaining. A couple phone calls a week was all it took. And all of them were happy to hear from me - many hadn't been contacted by anyone in the group for years! It's not hard, people. The database is readily available. We

ExCOM MEETING MINUTES

The monthly meeting of TGSF's Executive Committee was held in Sebastopol, CA at Nicole and Debbie's home on April 8, 2001 at 4:00 p.m. In attendance were President Nicole Cook, Vice President Aiyana Eveningstar, Secretary and acting Treasurer Debbie Cook, Education Co-Chair Stephanie Ann Blythe, Social Co-Chair Serena Anderson, Outreach Co-Chair Kalani Makanani and Outreach Co-Chair Telzey Adams. Social Co-Chair Tianna DeVil and Education Co-Chair Jennifer Antoinette were absent. Rachael Janelle and Janis Ryan were guests. The meeting was called to order at 4:05pm.



President: Nicole started the meeting by handing out revised Executive Committee Notebooks to those members who are running unopposed for the 2001-2002 ExCom. The President, Secretary and Treasurer received diskettes along with their notebooks with backups of important information including the membership database, the General Journal, the Bylaws and budget information. Nicole mentioned that in the notebooks are copies of the original documents which include the DBA paperwork, CCC, Tax Id information and any other official documents that were thought missing. Standing rules were updated for Secretary, Treasurer, Outreach and Education Chairs. A new section has been added to the notebooks on How To Produce A Cotillion. This includes contracts, timelines, layouts, deadlines, publicity information, insurance information, contestant guidelines, budgets, etc. This will be helpful for anyone coming into the ExCom and needs to know how the Cotillion should be produced. Rachael mentioned that the surrounding event information needs to be added. This needs to be created and added before the next ExCom.

We have received, from the letter we had sent out to doctors asking for donations, a check for \$100 from Dr. Broussard in Canada to be added to the TGSF Education Fund. We have also started receiving donations from members that will help to cover the last bill received from the Design Center. We have also made a \$200 donation to Project Open Hand and a \$200 donation to the FXB fund for children with AIDS. As on right now, the last Cotillion bill is all that is left to take care of.

Awards were discussed for the next End of Month social. They generally go to those members who have helped an Executive Chair in any way during the year to make their job easier. Serena wonders if the person nominated for an award needs to be a member of TGSF. Nicole mentioned that it cannot be an ExCom member, but traditionally, they have been members of TGSF. There is no reason why it cannot be someone outside of TGSF though. Debbie needs to know at least a week before the social so the certificates can be made.

Based on the numbers right now, we have spent more money than we have made this year. Last year, we earned more due to an increase in advertising by Ayme helping out. Rachael mentioned that since she has a database of advertisers from the Cotillion that she may be interested in pushing for advertising from those who normally only advertise in the Cotillion brochure.

Nicole mentioned the transfer of TGSF supplies and property. It is sorted out and we would like to get it to the correct ExCom members. We also hold all of the Social chair supplies for the Halloween Party as well as a large box of office supplies. Anyone who has room to hold some of the property and supplies would be greatly appreciated if we could transfer it to them for storage. Serena asked about the use of the TGSF shared office space in the new Community Center. The room will not be big

enough to hold all of our supplies, but the telephone and flyers be transferred there. The library may be able to be merged into managed by the Community Center library if they have one then

Vice President: The last Saturday in January was requested for next year's Cotillion. Aiyana is considering looking into Fort Mason as a place to hold the Cotillion.

There was no post-mortem meeting for the cotillion. A meeting time and day couldn't be coordinated with everyone, so Aiyana talked with everyone on the phone to get some ideas of things that could be done better next year. Marcia Chapdelaine mentioned that the Cotillion concept seemed to be getting old since we were covered many times before by the media, but this is really our event that has gone on for many years, allowing members of the TG community to come out and shine. Aiyana thought of ways that could save us money, but for many people, those cost savings like colored tickets and the debutante parade, are important to those who are coming out for the first time. It is a keepsake or memory that is a wonderful thing to keep.

Marcia also indicated the importance of the PR duties and mentioned she may be interested in doing that job. LeChara's name was also brought up in this discussion and Nicole mentioned that we had more than 1 person doing PR the year we had the good press coverage. LeChara was a really great PR person last year and Aiyana hopes we may be able to get her again.

Aiyana has submitted the applications for the 2001 Pride Parade early so we were able to pay less than we usually do. Miss TGSF has a lot of input into the idea behind the building of the float. The theme of the parade this year is "Queerific!!". Aiyana asked for any ideas on building a float for that theme if anyone can come up with one. Rachael mentioned that we should hand out flyers for the Cotillion and for membership at the parade this year.

Secretary: Membership is at 248 which is 3 below than last year, but I am confident that we will end on a positive membership note. Debbie mentioned that Dear Diva has had a request from her royal highness Chablis has requested those of us who had performed at the Emperor Jose's gravesite to perform the snow scene from the Nutcracker at the next San Francisco Coronation. This is on February 23, 2002. Stephan will be designing the costumes that will be more elegant than the last tutu's we wore at the gravesite doing Swan Lake. We will have a stage and everything this time. Diva is looking for 12 people to participate.

Last month's meeting minutes were approved.

Tax cleanup is continuing. After sending a request for information from the 1998 tax year and the IRS called to say they couldn't find any information on our tax filing from that year so they will be returning our fee we paid to get copies. The 1999 taxes have been deferred to the next ExCom since last terms Treasurer will be the next terms Secretary and hopefully she will be in a better position to get the financial information which the current Treasurer was not able to receive in time to do last years taxes. The 2000 taxes are still being worked on and will be completed by the turnover meeting.

Editor: The newsletter went out on time which contained a ballot for the election, a donation letter and a Cal Dreamin' flyer. We are on budget.

Publicist: There were no advertising renewals this month.

Treasurer: We currently have \$1,200.78 in the bank account and are so far in good condition as far as the bank account goes, but we still don't have enough to pay the last bill from the venue. A new category has been set up in the General Journal for the Education Fund and the \$100 that was donated by Dr. Broussard was added to that category.

DEAR TGSF,

One of the greatest things that I have discovered about the Transgender Community is its diversity. I have met within TGSF and other groups, people with occupations ranging alphabetically from Accountant, Acupuncturist and Attorney to Window Washer and Zoologist. And with the vast musical talent that exists I wouldn't be surprised to find a Quixotic Xylophonist to help fill in the high-value letters in Scrabble.

Unfortunately, as with other groups of people differences in personality and opinions also arise. People become extremely active in leadership roles, become "burned out," and leave. With their departure the knowledge and experience that they have gained is often lost.

I was deeply disturbed and disappointed that the long-established election procedures stated in the TGSF Bylaws were not followed this year. They provide that nominations at the February end-of-month meeting, and allow candidates to present their position statements before the election to the membership here in our newsletter, *The Channel*. That has not been possible this year, and this message will appear after the election has been completed.

At my first meeting in February 1998 I remember Leslie and Lulu being nominated for President and Vice-president, positions that they subsequently held for two years. At my anniversary meeting in 1999 I was nominated for Treasurer, and a year later I was nominated for President. This year very few members were present at the February meeting, no nominations were made, and the ExCom was represented only by Vice-president Aiyana and Social Co-chair Tianna.

I pledge that if I am elected as Secretary of TGSF I will complete the unfinished business of formally changing our name from Educational TV Channel to TransGender San Francisco. I will provide copies of the current Bylaws, which were adopted by an overwhelming vote of our membership, to both the ExCom and membership, and will implement the provision regarding the term of membership. I will continue to seek the advice of the members of our group, particularly those who have been involved in events in the past.

The most important reason for the existence of TGSF and other groups in the Transgender Community is to provide a safe, encouraging place for people to come together and share their experiences in discovering themselves as transgendered individuals, and pursuing their goals. This what these groups have provided for me, and what through them I have personally tried to provide for others. Working together, we need to insure that this continues.

The shoemaker emerged from behind the worn red velvet curtain holding a single pair of soldier's boots, quite lovely, sea green with silver buckles. The provost, who had come with a cart expecting to collect dozens of boots not just one pair, cursed the shoemaker and whipped him with his swagger stick, not severely, just a couple of times to teach him a lesson.

"You foolish man to thwart me so. Do you see that cart? Next month I will return and you, my friend, will have produced enough boots for me to fill that cart." The shoemaker bowed low from the waist and in a voice quiet as crinkling paper bade the provost good day.

One month later, to the hour, the provost returned wearing the sea green boots with silver buckles.

NTAC SUPPORTS ONGOING WINN-DIXIE PROTESTS

It's been over a year since truck driver Peter Oiler was fired by the Winn-Dixie Corporation because, according to the company, his cross-dressing outside of work just didn't conform to the proper company image.

Winn-Dixie, however, has said virtually nothing publicly concerning the case. "They're silent," said Eric Ferrero of the ACLU, who is representing Mr. Oiler, "because it's hard to explain the unlawful and un-American bigotry of firing Peter Oiler because away from work he didn't look or act the way they thought a man should."

However, the transgender community will remain anything but silent about the treatment of Mr. Oiler. There are planned protests against Winn-Dixie in Atlanta during the month of April, and further planned actions to take place against Winn-Dixie regional headquarters in Clayton, NC. The date for the North Carolina action has yet to be confirmed.

Contacted at home, Peter and his wife Shirley expressed their happiness at the continuing concern shown by the Trans community.

"I think it's great," said Shirley. "We think that is wonderful that people are still interested in our cause and are willing to show it. We want to thank them for their support and their willingness to take some form of action - write letters, make phone calls, let the local management know..."

"It's management that's the problem," said Peter. "Unfortunately, because of their attitude, all this is necessary. For every action, there is an equal and opposite reaction. They choose to ignore their own options, so it's coming back on them."

Due to the coverage the cause has generated, Peter and Shirley have become members of Renaissance for a year. They have also been guest speakers at an NTAC reception in Washington DC and have been invited to other events as well.

NTAC (The National Transgender Advocacy Coalition) supports all upcoming actions on the behalf of Peter and Shirley Oiler. Please join NTAC in boycotting Winn-Dixie, and tell your friends why you refuse to shop at their stores. Protesting acts of discrimination against transgendered people, and making others aware such discrimination happens, will be our foundation for change.

ARE TRANSSEXUAL WOMEN "REAL" WOMEN? YES.

Are transsexual women "real" women? It's a tedious question that male-to-female transsexuals often run up against when they're open and honest about their personal history. But the life experiences of many MTFs make them more aware of how gender roles and sexism work than a lot of so-called "real" women.

I've never met a transsexual woman who didn't have a feminist consciousness. I'm sure there are some, but it makes perfect sense that many trans-women would be attracted to feminism as a philosophy. After all, feminism by definition seeks to break down the barriers society has set up based on gender.

It's infuriating, then, that some feminists and lesbians continue to question the "womanhood" of MTFs. I support the concept of "women-only space," but I'm concerned that this legitimate policy is sometimes used to discriminate against trans-women.

The Michigan Womyn's Music Festival, for example, still maintains a policy of trans-exclusion that sounds eerily like the "don't ask, don't tell" policy of the U.S. military. An official festival hand-out states, "No woman's gender will be questioned on the land." However, the flyer goes on, the festival has the right to deny admission "to individuals who self-declare as male-to-female transsexuals." In theory, one of Fred Phelps's daughters could attend Michigan, while an open feminist trans-woman could not.

In another galling example, a women's rape crisis center in British Columbia recently refused to allow Kimberly Nixon, a transsexual woman, to train as a peer counselor. The staff assumed she wouldn't understand violence against women because she was born male. According to a center spokesperson, Nixon could not possibly have faced the unique mix of social, psychological, and biological factors that "shape women's experiences and ... the world's perception of us."

But, in fact, the experience of many transsexual women turns the meaning of being "born" female or male upside down. Many MTFs talk about knowing they were "female" from a very young age. "Growing up," Nixon told a reporter for Canadian Press, "I had the sense and burden of being female and the burden of being aware of ... all the issues women deal with."

The exclusionary policies that feminist and lesbian groups institute toward transsexual women rest on two false premises. First of all, because the world once viewed MTFs as boys and men, it's assumed that they enjoyed male privilege. Yet the opposite may actually be true, given the many stories transsexual women tell about the intense gender oppression they experienced before surgery.

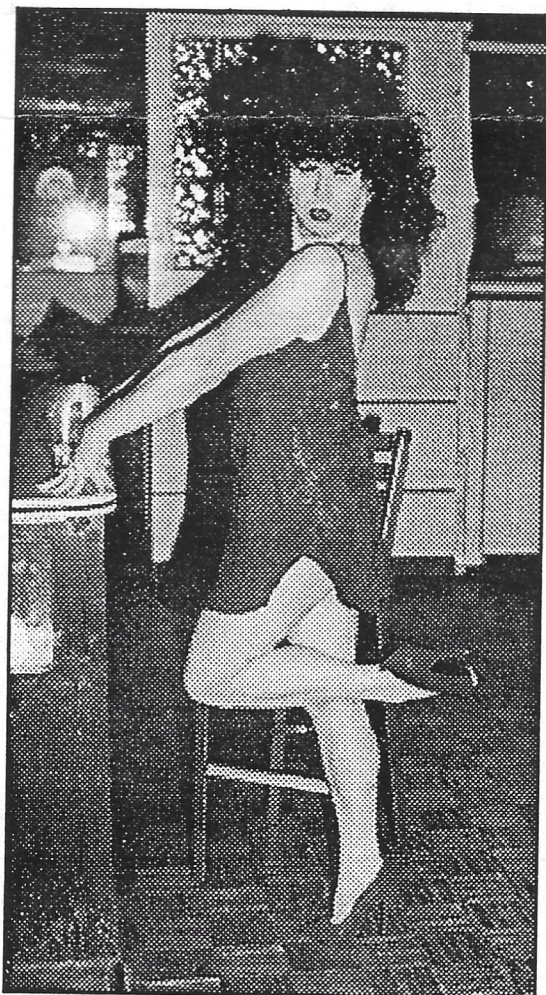
Are TS's "Real" Women?...

According to Australian trans-feminist Julie Peters, transgender male youth tend to be regarded "as feminine or different boys and are denied entry into male power structures; they are vilified, ostracized, and bashed." Misunderstood or rejected by their families, they sometimes take to the streets, where they're at high risk for drugs and prostitution and often learn early on about sexual violence, just like many girls do.

The second false premise is that only "real" women can fully comprehend female oppression. But what about the "real" women who think feminism has nothing to do with their lives? And don't forget the "women-born women" who actively oppose abortion rights, or who accept their church's dictate that wives submit to their husbands, or who voted for George W. Bush.

Now compare those "real" women with trans-activist Riki Wilchins, Executive Director of GenderPAC. In a recent editorial, Wilchins called on activists to build "a broad-based and inclusive national movement for gender rights." Gender, Wilchins states, is a basic human right that unites everyone from "a boy-dyke with buzz-cut blue hair" to "an FTM fired for transitioning on the job" to "a soccer mom banging her head on the glass ceiling" to "a gay man genderbashed ... because some bigot thinks homosexuals are unmanly."

We can learn a lot from reading the work of cutting-edge activists like Wilchins. But even older trans-women, who transitioned long before the founding of the National Organization for Women or the riots at the Stonewall Inn, have gone through their own transformative process and come out as feminists.

In an engaging new memoir called *The Woman I Was Not Born to Be*, Aleshia Brevard, a former drag performer and actor, describes her own personal journey. Glancing through the book's photos of Brevard boasting long, painted nails and a cinched-in, hourglass figure, you might be tempted to rehash the old feminist complaint that MTFs simply reinforce gender stereotypes rather than break them down.

But, in fact, Brevard has a strong feminist sensibility. After transitioning, she slowly came to realize that the role she envisioned for herself as a Donna Reed-style wife was too limited. Instead of clinging to the belief that "a good woman must be docile and long suffering" and invariably attached to a man, she recognized that she could be happily fulfilled as an independent woman.

The liberation of her mind, Brevard says, took much longer than the physical reconstruction of her body. Her experiences and those of other trans-women hold important lessons for feminists and lesbians who remain stubbornly hung up on biology.

nately, some of these people will do everything in their power to disrupt the work of those who do not agree with them. This type of effort is disruptive to the good of the organization. Some of you may already be aware that I am the target of one of these people.

In an ideal scenario, it had been my hope that the person in question would have remained in the membership until I had finished my run in the Executive Committee (which would have been a year or two longer). At which time she could have returned to the Executive Committee and served several years herself. This scenario would have yielded a total of around 10 woman-years of volunteer service in the Executive Committee, assuming we both served for 5 years.

As a result, I think we have successfully averted any potential conflict in the election process and the group will remain unified. As a result of my decision not to run for President, the person in question ran un-opposed for the position of Secretary. I hope she can appreciate my decision.

It is entirely possible that I might once again serve on the Executive Committee, provided you the membership want me to. It is my hope that at some point in the future we will have more members running in friendly elections for positions on the Executive Committee.

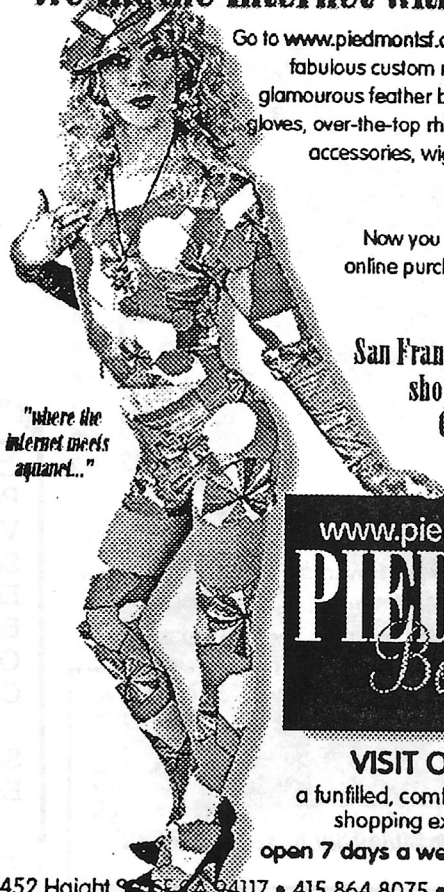
