

Not the song, the convention, which is coming to San Francisco April 1996, when leaves are green and the skies...well, whatever color they are, where's a better place to hold a convention?

Started in L.A. five years ago, California Dreamin' in '96 enters a new phase as a traveling regional event. Southern Cal clubs continue to do the heavy lifting, with Northern Cal clubs invited to participate as co-hosts as much or as little as they wish. ETVC and DVG have already signed on. We hope to recruit at least a couple more groups. How big we go with this ultimately depends not only upon the number of clubs but the number of people who participate. Class, what's August 19? Yeah, sure, the 36th anniversary of the day I joined the United States Navy. What else? It's one of the three dates (August 18, 19, 20) of the first AllFTM Conference of the Americas being held at New College and New College School of Law.

FTM's have come a long way in a short time. A few years ago, they were a hidden minority. Today, FTM leaders such as James Green are at the forefront of the entire transgender community. Police Sgt. Stephan Thorne was the first transsexual to go public after civil rights were granted to TG S.F. City workers in a November 1993 charter reform (though he was about to do it anyway, before he knew about the law). James, Stephan and many others will stage what promises to be an exciting event. Look for more information elsewhere in this issue.

Charter reform reminds me to remind you that Shelley Salieri, who authored the TG protections section (which earned her ETVC's Outstanding Achievement Award), has suffered a stroke that paralyzed her legs. As of this writing — about a month before you receive The Channel — Shelley resides at Laguna Honda Hospital, Ward M5, in San Francisco, undergoing physical therapy. Shelley has worked tirelessly for our rights. A call (415-664-1580), a letter or a visit would cheer her, and is certain to speed her recovery. Somber note: Shelley has had to register as a man — a bitter irony — reminding us that our advancement still falls short of the goal.







Night Man

Rite of Passage
Francis Vavra

For several years, I have been seriously contemplating getting a tattoo. Beyond simply being a beautiful design somewhere on my body, the idea of something so permanent and personal stirred strong ancient feelings within myself. Tattooing is such an old ritual, primitive societies originally gave themselves sacred designs denoting special events in their lives, such as coming of age, marriage, or denoting a particular tribe or gender. Though many women in this country are using tattoos as personal adornments, I felt receiving one would be a personal statement about my maleness, and I wanted a woman to do it. For me it symbolized commitment, pain withstood, and a private symbology to be worn the rest of my life. Even though I don't feel I actually am a man, I still relate to a feeling of maleness more than femaleness, a concept difficult to describe. I have been handdrawing a small rose on my business cards, and often give roses to my dates. Recently I discovered that the rose is an old symbol of transformation, along with butterflies and fairies, other favorite images of mine. So a rose, with feather leaves, thorns and blood drops (for my vampire tendencies) was what I chose for my tattoo.

Last year I found the person I wanted to perform this artistic ritual, a wonderful eclectic spiritual woman living in the Mendocino, California area. I wasn't quite ready then; now I was. I had just lost my secure, stable, soul-stifling job of eight years, was in my ninth month on male hormones, and had begun a burst of creative energy. Floating between worlds, I was ready for a rite of passage. I made the

appointment, rented a blood red car (coincidental) and with state of the art sound system blaring gypsy music, drove up the coast in a 3 1/2 hour non-stop meditation which continued in Madame Chinchilla's tattoo studio. She carefully sketched the design on my right arm, had me sit awhile looking at it in a mirror, and when it was exactly to my liking, Chinchilla ("Chi Chi" for short) applied fresh lipstick (on herself, her personal ritual), offered me a mint, and began her artistry. She does very delicate, precise work and had designed the stem to give the illusion of entering and exiting my skin. It took three hours, and as my gypsy tape played on her boom box, we became close, the pain was much less than I had expected, my endorphins kicked in and I became euphoric, and when it was over, I treated Chi Chi, her partner and a friend to dinner at an East Indian restaurant, as we were all famished.

The following day I returned, having decided I wanted the stem lengthened, but she couldn't work on it again for another 3 weeks as the healing process had begun. Instead, she excitedly pointed out that this very date, May 16, was the anniversary date in 1944 on which a number of Jewish women and gypsies were non-consensually tattooed with numbers at Auschwitz, and she had a list of them in her tattoo museum. Jewish herself, Chinchilla spontaneously decided to have one of those numbers tattooed on herself in remembrance. Without hesitation, I decided to have her tattoo a tiny "Z" on my left shoulder, in memory of my unknown gypsy relatives who died there, as all gypsies had Z's (for "zigeneur", German for gypsy) prior to their numbers. As she marked the letter in traditional dark blue ink, I thought about the pink triangles for gay men, black triangles for lesbians, yellow Stars of David and the gypsies playing violin music in the camps. We both cried and hugged each other, and said our farewells. I spent the rest of the day sitting among the trees along the Mendocino coast watching the waves crash over the rocks, and slept in my car that night in a campground beneath the stars, feeling the rose and the "Z" throbbing on my arms, and gypsy music playing in my head.



As she vanished in the air



The New Woman

The phone call came this morning. One of the local papers is running a story about my latest bout with the State of California over employment rights issues and wanted a photograph. "Would I be home at two for a photo shot?"

"Sure I'll be home", I said, but I knew this was different. The article and the picture were for a prominent gay newspaper, and represented a coming together, a healing so to speak, wherein at least in this, we speak as one community for our right to work without fear of discrimination.

This for me has been a long time in the making. I have been convinced from the beginning that the struggle for transsexual rights are tied both now and historically to gay rights. Yet from January of 1994, when I first began dealing with the press, it saddened and confused me to meet others who felt passionately otherwise. It saddened me because I am all too familiar with the strategy of "Divide and Conquer". It confused me because to those in the workplace who called me a "faggot", there is no distinction. The average guy does not appreciate the subtle differences in the Diverse Lifestyles Community, and he certainly is not privy to our enumerable theorists. To him we are all the enemy, the same enemy.

The Gay Press is now taking notice of my case, for the State, in its latest attempt to avoid responsibility to its citizens, says:

"Since you had clarified to your employer that you were not gay before you were laid off in August 1994, it would be difficult to establish that he discriminated against you because he perceived

you to be gay. You would in essence have to prove that the employer did not believe your statement that you were not gay, and then took action against you because of your perceived sexual orientation."

Simple enough, however:

One of the great tragedies of life in the United States is that many of its most productive citizens must live and work in fear simply because they are members of a minority. It is difficult to imagine the number of gay men and women who have denied their true nature when confronted by an accusing supervisor or employer in a workplace confrontation. Denial does not protect one from discrimination. Many of us were shocked to learn the Department of Industrial Relations, as a result of this ruling, was now prepared to withhold or severely limit protection to anyone who was discriminated against as a gay, simply because they told their boss they weren't. Sort of a reverse "Don't ask Don't tell" policy. Common decency and the spirit of fair play dictates one examines the actions and events and not absolve someone of responsibility for their actions based solely on selective definition of terms.

The State of California must be held accountable for protecting its citizens from abuse. And it must be encouraged to enforce its own laws.

I am thankful to the press for its realization of the importance of this ruling. The political mood is not favorable to protecting our right to live and work as productive citizens. Together, we can prevent erosion of those laws designed to protect us from abuse, and if we remain aggressive in our stand, we can increase protection, until one day all of us, including those of us who are transsexual, feel secure under California law.

Respect: the Old Fashioned Way

I walked into the San Francisco State University Student Union poolroom as inconspicuously as possible, as I was entering a male domain. I casually walked up to the person who looked to be in charge and asked about the upcoming nine ball tournament. Julie, the assistant manager, enthusiastically encouraged my participating in the women's division as they were always welcoming new coeds. I agreed to enter the tournament if I could play in the open division but was told that play there was much more competitive and that men generally played in that division.

I assume that most people know I am transgendered, but I'm told I blend well and that I'm my harshest critic. Regardless, I didn't want to start another Renee Richards controversy, I just wanted to compete in a game I enjoyed and haven't played for a very long time. I remained firm and after showing my student ID was allowed to register for entry in the SFSU Spring Open Division Nine Ball Tournament. I was given some instructions and told to arrive on Saturday, April 29, 1995, before 10:00 for the first round.

Saturday arrived soon enough. What should I wear? It was overcast and threatening to rain. My usual shorts or jeans? I suppose jeans and athletic shoes were more appropriate as I'd be bending over the table on some of the shots. But I'm pretty bold, what with interacting with literally thousands of students daily, so I opted for the comfort of shorts which as it turned out, made only me feel comfortable. About 9:30 a.m. I walked into the tournament room amidst the sound of clicking balls and enough testosterone to start a war. I made my way around groups of male students as they not so discreetly eyed my every move. I reached the registration area unscathed but felt as if I had been visually raped — is there such a thing? Anthony, the poolroom manager, greeted me and asked if I wasn't sure I'd rather participate in the women's division as I'd be competing against up to 40 men in the open division. I said I'd prefer to play in the open division. He wished me luck and that I could warm up at one of the table prior to starting the tournament. I picked out a house cue which instantly set me apart from the other contestants, as they all had expensive custom cues with fancy leather cases. I walked up to a table with several players and asked if I could practice with them. One of them said the tables were reserved for contestants. I said I was one and that I'd like to play with them. They said I could play the winner of the game in progress. As I waited, I examined my house cue. It looked fairly straight and the tip looked good. It wasn't like one of the custom cues that the other players were using but, as we all know, looks can be deceiving. They continued practicing and seemed irritated by my presence. My turn came so I racked the balls for my opponent. He broke but nothing went in. It was my turn. I hadn't picked up a cue in over six years, so it felt pretty foreign as I eyed my first shot. A tough, long cut shot on the one ball with difficult position on the two. I made the one and ran out the rest of the rack. I heard someone whisper, "She's just luck," and "This is only practice, just wait until the tournament."

I should mention here that before transitioning, I was a pretty decent pool player. I took up the game when I was thirteen so you might say I have quite a few years of experience. I was the caliber of player who traveled to other cities and states in order to find a game. I played for money primarily and also won quite a few local tournaments. But that was then. Other things became more

important in my life so I gave up playing pool.

The tournament started promptly at 10:00 a.m. The format was double elimination, race to five. This meant that for each match between two contestants, the first to win five games won the match. The double elimination format allowed you to lose two matches prior to being eliminated. At the end of the day, there would be a winner of the winner's bracket, who would have no losses, and a winner of the loser's bracket who would have one loss. The two bracket winners would face off to determine the champion. The first round match-ups were announced on P.A. I didn't hear my name so I went outside to have cup of coffee and spend a few minutes studying. One of my girlfriends came by to see what I was up to. The first thing she said was, "I can't believe you wore shorts, especially those shorts. You are asking for trouble!" I was expecting a "good luck" or something like that. At about 10:45 a.m. I heard my name announced. Extremely nervous as I returned to the tournament area, as I entered the room I got the feeling that because I was a coed, some resented my participating in the open division. I could just imagine them thinking, "that's why there's a women's division." I interpreted this silent opposition as, "women just aren't as good as men." I also had the feeling that the women there felt as if I had abandoned them. Such is the world of being in-between. I had to weave my way to my assigned table, no one made way for me which made maneuvering a competition all by itself.

By 6:00 p.m. I was the sole undefeated contestant in the winner's bracket, which meant I only had to win one more match to become school champion. Up to this point, no one had won more than two games against me. I waited for the outcome of the remaining loser's bracket matches. I got cold, I was tired and hungry. The restaurants had all closed. I waited for an hour and a half until the championship match was announced. My opponent, whom I had already tortured with a score of five to one looked pumped and eager for revenge. He won the coin toss and won the first game. I was unconcerned. He also won the second and third game, I started to worry. I had lost my momentum and my concentration. I no longer cared about winning, I was only fearful of failure and defeat. I needed to be aggressive. For a moment, I regretted taking my estrogen that morning. I managed to win two games but by now, the score was two to four, my opponent was breaking and needed only one game to win, and I needed a miracle. He broke and failed to pocket a ball. It was my turn. I bent over the shoot. I paused to look at the trophy which stood about two feet high and had marbled tiers. It was absolutely stunning. Instead of shooting, I got back up and thought, wouldn't it be something to be the first transsexual SFSU pool champion, and in the open division no less. I was re-inspired. But I had to win the next three games. I tried to do the best that I could.

As I compose this story, I can look up and see the trophy as it sits atop my desk. I moved to the Tenderloin recently and can only afford this cozy little studio so I have no other place to put it. It looks somewhat out of place here amidst all my books. I look at the inscription — 1st PLACE, NINE BALL - OPEN DIVISION, SFSU SPRING 1995. I am so proud. I was on the Metro on the way home after the tournament and someone said, "Way to go, Stephanie," I looked up to see Anthony. He looked at my trophy and asked if I'd noticed that the statue on top was a male. No, I hadn't noticed. He said the university hadn't anticipated a woman winning the open event and made an offer to send the trophy back for a female figurehead. I said, "I think I'd like that."

Ask The Therapist
Relationships - Are You Available?
 by Luanna Rodgers,

One of the true joys of life is a loving relationship with a special other person; a mate, a loved one. Too often single people who crossdress, gender blend, or cross gender boundaries, feel insecure about meeting and getting close to possible significant others because they fear rejection. Often, especially in the early stages of coming to terms with cross-gender feelings, the individual believes that the self-doubt and condemnation they hold towards themselves is shared by all others. This leads to reclusiveness, reluctance to seek partners, or, if already involved, to fear disclosing to that partner, all leading in turn to a plummeting sense of self-worth and increased insecurity about their desirability as a partner for someone.

As a therapist working primarily with crossdressers, transgenderists and transsexuals, I find that one of the most common concerns is finding or maintaining a loving relationship. I believe that one of the primary stumbling blocks to finding that special other with whom you may form a relationship is a reticence toward or active rejection of oneself as a crossdresser or cross-gendered individual. Very often I hear people state that their ideal partner would like and value them for themselves, their whole person, but not like or be attracted to their crossdressing, gender blending, or cross-genderism. Certainly no one wants to be objectified and appreciated as a one-dimensional character: a crossdresser, a transsexual. Why though the failure to embrace oneself fully and allow others to appreciate them in their true wholeness? For example, the leggy blonde does not want to meet someone who only likes her because she is long-legged with blonde hair. But is she likely to be upset with someone who enjoys her intelligence, enthusiasm for life, love of children, animals and opera,

plus likes long-legged blondes? Probably not. Yet many crossdressing and cross-gendered individuals grapple with this very issue.

"I wouldn't belong to a club that would have me as a member" stated Groucho Marx. Many cross-gender individuals seem to be saying they wouldn't belong to a partner who would have them. I've heard crossdressing and cross-gendered people say they feel uncomfortable if someone seems interested or "turned on" by them and their status. Over the years, many of my clients have stated that they would try a personals ad but they are afraid that, if they stated their gender status, they wouldn't get any replies or would get only replies from people "into" crossdressers or cross-gender people. Again, the example of the leggy blonde: why try to deny oneself and attract someone who only wants a short brunette? Only shame about oneself, in this case transphobia, could explain the rejection, suspicion and constant testing of those who accept crossdressing or cross-gender status in a partner.

If you are single and seeking a partner, it may be worthwhile considering your own self-image and level of self-acceptance. Are you afraid of meeting and dating prospective partners? Would you scrutinize to within an inch of their life any partner who expressed an interest in you? Does your sense of self-doubt and low self-worth convey the label of pervert on any prospective partner who would accept you totality as a crossdresser or crossgender person? Is that what you call yourself in your deepest, secret moments? If so, you are probably not truly available to be loved and cared for. Consulting a knowledgeable gender therapist, attending a supportive group, or talking to others who have worked through this issue themselves could help you free yourself from the barriers preventing you from forming a successful, rewarding, intimate relationship.
