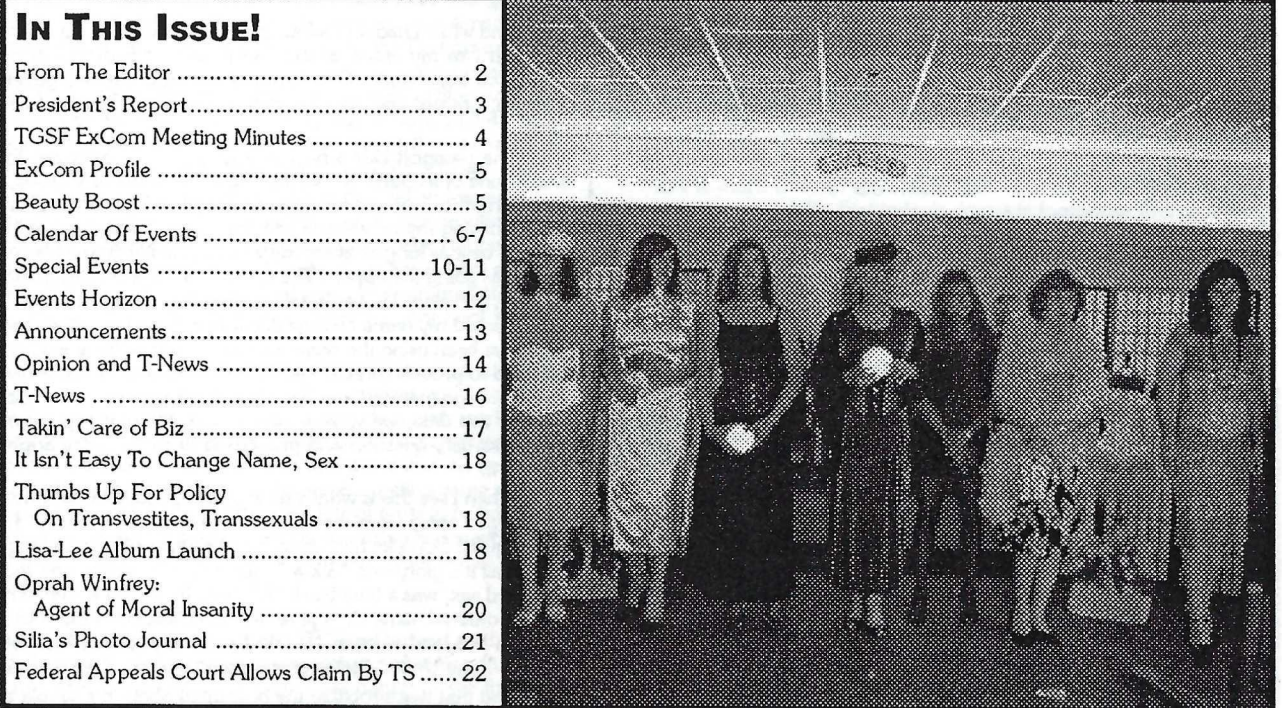

## FROM THE EDITOR...



It's been over 40 years since I was last on an ocean-going passenger liner, traveling with my family to follow Father across the Atlantic for a one-year Sabbatical in London. Since I was only 7 at the time, I only have vague memories and flashback images as mementos of that voyage.

But now in this day of digital photography, I have more concrete proof of our most recent adventure to the mysterious, wild and rugged Northwest, to what the locals up there call the "Panhandle," the southeast piece of Alaska - the land of such marvels as the Inside Passage, the Tongas National Forest, the Misty Fjords, the Mendenhall and Hubbard Glaciers, and the historic narrow gauge railway up the Yukon River to the White Pass summit, gateway to Klondike Gold.

Now if you want to be absolutely spoiled rotten and pampered to the extreme, then take a cruise. I am totally sold on cruises as my vacation of choice from here on out. You don't have to drive anywhere, don't have to worry about hotel rooms or where to eat. Just get on board and leave your brain behind. You need do nothing but what they tell you. Hungry? Just eat. Doesn't matter what time of day it is, there's always something to eat on a cruise ship. Though I have to confess, there truly is a limit to the number of 5-course dinners one can eat in a row. Beyond the 5-star white glove service, our ship (Celebrity's Mercury) had 110 chefs churning out 9,000 hand-made French nouvelle cuisine masterpieces a day. And that didn't include the 24-hour room service, the all-day and late-night buffet troughs, the hamburger and hot dog grill poolside, the sushi bar and the midnight pizza and pasta bar.

It was probably the best vacation I've ever had in my life. Nine glorious nights of incredible cuisine, fascinating glimpses at the wildlife (Humpback and Orca whales, Eagles everywhere!), breathtaking scenery, interesting offshore excursions, plenty of onboard activities including a hoity toidy "aqua spa" and a swingin' casino, a fine assortment of duty-free shopping, and pretty good live entertainment. I was never bored, and with 14 decks there was always plenty of space for everyone. Besides, if you're a clothes horse like me, the "formal" dining evenings were a real treat (and consequently, lends itself very nicely to overpacking for the occasion).

Treat yourself. Take a cruise - doesn't matter where: Alaska, Caribbean, Mediterranean, Europe, South America, Hawaii - just go once in your life. But do your homework. We learned that Frommer's puts out an excellent book that compares cruise lines, what ports they service, what itineraries they follow, passenger loads, cruise speed, tonnage and stability ratings. Depending on the route, smaller ships (1,300 passengers or so) get tossed about more on an open sea, but there's a lot to be said about having fewer people on board. Different lines cater to different crowds. Carnival, for instance, targets the 20- to 30-year old party animals, whereas Celebrity or Holland will attract elder retirees and a smattering of families with small children.

And while I had a fabulous time in Alaska, that wasn't what I wanted to write about. It was my ordeal at the San Francisco Federal Passport Office where my adventure truly began. For there it was that our lovely government, in its infinite wisdom, granted me full status as female without the necessity of my having a vagina.

The passport was a necessity as our itinerary began in Vancouver, BC and had as one of its ports of call, the beautiful capital of Victoria. Now I went in to the passport office with a mind to just be legal so I could travel unhindered, and if that meant having my new name with an "a.k.a." and a gender marker of "M" on it, then so be it as long as everyone was satisfied as to my identity. And at first, that's what was going to happen. The supervisor we were assigned to asked me if I'd had surgery, and since I haven't, told me my new passport would be as I expected. She then wanted my name change documentation, but since I never got a court order and have been using the common-usage method here in California (since 1991), I was told to provide three original documents with my new name and dated at least five years ago (paystub, gas bill, etc.). After a frantic drive back to Walnut Creek to retrieve this data, we were assigned to a different supervisor who didn't ask the crucial surgery question and proceeded to process my application assuming that I'd had it.

When I see this is what's taking place, I nudged Sappho in the ribs slyly when he stepped away from the window and whispered out of the side of my mouth, "keep quiet! Don't let him know he's fucking up!" Ba da bing, ba da boom there it was in all it's glory - no "a.k.a." - just my new name, and there enshrined next to the word sex, was a little black "F." Now how cool is that? I no longer need to get a court ordered name change as my new Passport is the supreme identifying document in this land of ours. Nor do I need any genital reconstruction to prove I'm female. If the United States government says so, then who am I to argue?

And that was probably the best thing about the whole experience. Knowing that I had full rights and passage as an American citizen, and a female U.S. citizen at that. I tell 'ya, after 13 years of a personal journey filled with its share of trials, tribulations, and triumphs, it's always nice to be validated. Know what I mean?

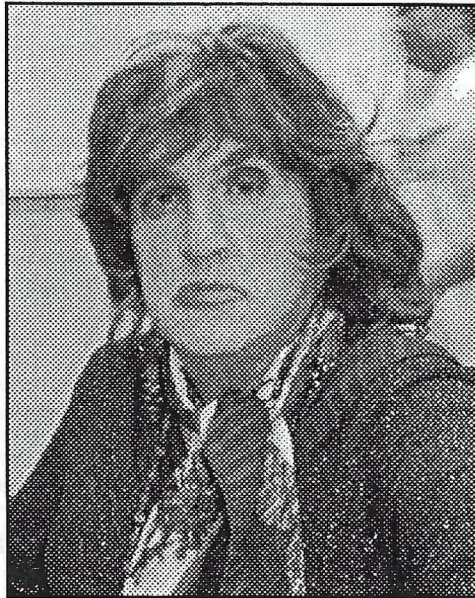

## TGSF ExCom MEETING MINUTES

Present: Roxy Carmichael-Hart, Laura Marlowe, Pamela Gray, Allison Laureano, Dawnne Woodie, Kara Flynn, Anne-Louise Mortensen, Tommi Watson. Guest: Tyler Fong. Absent: Siobhan Ellis, Damon Helton. Meeting Minutes of August 1 were approved as submitted.

### President's Report

Roxy stated that she would like Mr. and Miss TGSF to participate in the upcoming events including Hayward Pride (9/18), Folsom Street Fair (9/25), and Castro Street Fair (10/3). Roxy was also concerned about recent emails on the Yahoo group "tgsf", and because of the liability of those emails, prefers that the link on the tgsf.org webpage be removed. Kara stated that she could set up a different Yahoo group and would have the ExCom trial the new group to see if it was ok.

### Vice President's Report

Laura reported that TGSF had a fabulous Cotillion Planning Meeting. She reported that we're still working on contracts, contestant and ad packages, and that she is working with Ally on food items.

### Treasurer's Report

Pamela stated that there was about \$6000 in the account. We still owe Tyler \$300, as well as Susan, with Roxy looking up the final numbers on financial information. Pamela stated that the Federal tax form is fine and she is checking the return with the California State Franchise Tax Board. Dawnne is to arrange an updated list of advertisers (from Ayme).

### Secretary's Report

The PDF for the September Channel was received and 150 copies of the Channel were produced this week. Dawnne and Tommie are preparing and distributing the Channels. Ally was appointed to write the next profile by September 15 for the October Channel. A picture will also be needed to accompany the profile.

### Education

Dawnne stated that Luana Rogers and Dr. Cholon will be at the next End of Month Social. She is also communicating with Willie Wilkenson for a Health Law Event. The TGSF Beauty Magic Day is planned for 9/18 with speakers lined up and confirmed.

### Outreach

Kara went over some of the calls from the hotline and reported that she has sent out all of the flyers except for the "Am I A Transsexual". Roxy asked for the calendar to be regularly updated. Allison and Bobby participated in the International Students Panel and said that they received most of the questions. Allison is arranging the logistics for a booth at Folsom Street Fair, Castro Street Fair, and Hayward Pride. She has the applications and needs the 501c3 information. She has the insurance papers but needs to clear up the Folsom Street Fair insurance information. Folsom will cost \$175, Castro \$200, and she hasn't heard back from Hayward. A group discussion was held proposing a PG-13 presence at the Fairs, but no formal protocol was established. Only those working the booth or those on the Ex-Com would be allowed to work outreach during the events. The theme-catching ideas for the fairs included "Get Spanked by a Tranny" for Folsom and "Get Whipped by a Tranny" (whip cream) for Castro.



## Social

It was reported that the MAC event had 12 people. Roxy reported that the Wedding Party was a nice event and had great decorations. The party netted about \$150. Kara has reserved a picnic spot, but a flyer was still needed. Dawnne would be the person to barbecue. Carla will be hosting a Halloween Party on October 30th. Eddie Tavares will be supplying decorations. TGSF is not a sponsor. The current planned price for the event is \$25. Roxy reported that there had been no response from anyone to run a Mid-Month Social. Dawnne was talking to Oui Three Queens about events.

Anne Louise presented different ideas for activities including Transcendence Gospel Choir, Trans Central Station, and the Red & White Ball 2005/Butterfly Carnival.

## ExCom Profile

### OUTREACH CO-CHAIR, ALLISON D LAUREANO

Did you ever notice that short Filipina chick sitting in front corner of the Blue Muse during the TGSF End of Month Socials? She's the one that usually has a laptop with her as she eats ravioli and tries to track down vases or jars for donation collection. Yup, you guessed it, that's me. My name is Alli and I'm one of your fabulous Outreach Co-chairs and it's my turn to give you all a little insight about me.

Okay, briefly about me. I was born in the Philippines in 1972, but moved to rural Arkansas when I was four months old. Okay, I didn't move, but my parents moved me. I really didn't have any say in the matter so I went. I grew up for the first 15 years of my life in this little town, where I experienced the joys of hiking through woods and enjoying nature, to the sorrows of racial and ethnic prejudice - some of you have heard my story of walking in on a white supremacist gathering in the sticks. To this day, loud bangs like car backfires and balloons popping cause me to instinctively duck. And yes, I did have a thick Southern accent. I became very fluent in Southern, saying "Ya'll" and even adopting Gomer Pyle's "Golllllly". Yet I had to persevere, doing twice as well in school and other activities to prove myself half as good to my peers. The upshot to that is it instilled in me the deep conviction of learning and education, gathering knowledge to better oneself. This deep-seated passion carries through with me today. As I stated in my candidate statement earlier this year, I believe that only through education can we transcend tolerance for our community and achieve genuine acceptance that we are a part of this global community.

Okay okay, I know, you want to hear about the TG stuff. After all, this is TGSF. I transitioned in 1996, of all days on April Fool's Day. I don't know why I chose that day, it just sort of worked out like that. New Month, new life, etc. I did a transition education presentation at my work and found out that the entire office kinda already had a feeling, and they had absolutely no problem with it. It also just so happened that we had another person in the office who was also transitioning from female to male, so we made a morning session of it. It was perhaps the smoothest transition I have heard of, although I'm not bragging...not yet anyway, heh. Suffice it to say, I have been full time since then, and have even been stealth for the better part of 7 years, the last five of those in San Diego, where my job moved me. That was a tremendous experience as no one there knew my status, and I pretty much was just accepted as another business woman in our little corporate community... okay, well that sounds a little braggish, but oh well, we all must be somewhat proud of what little accomplishments we make in our life.

After having been laid off due to corporate cutbacks, I moved back to my adoptive home of San Francisco. I re-entered the TG community as I thought it was time to help others as I have been helped, and to facilitate the acceptance we all desperately need in our little "Mecca for transgender". To that end, I am extremely grateful for your faith in me to be a leader in TGSF. Your confidence in voting me to be amongst the many talented and dedicated leaders of your community has inspired me to commit an energetic effort in reaching out to not just our TG community, but to the entire Bay Area community at large. As many of you know, I have been pushing hard to give awareness and sensitivity talks and presentations in our local colleges. We have plans of expanding that community educational outreach to the police departments and health care service providers of the entire Bay Area.

I am also involved in a new start-up non-profit in which we hope to provide crisis outreach and intervention services to transgenders in some sort of dilemma, be it dealing with the actual gender identity, difficult living conditions, lack of care services, or imposed violence or abuse. Please stay tuned to this newsletter and other announcements in meetings and online for more upcoming information on this exciting new endeavor.

I am hopeful that with your help and support we can make TGSF the marquee organization for Social and Community outreach - with the mission of providing the education we need to the communities we live in. I am excited about our direction, and hope that ya'll (there's that word again) are too.

## Beauty Boost

### THE POWER OF FRAGRANCE

Years ago, a coworker gave me a bottle of perfume as a gift for my birthday. I was touched by the thoughtfulness of the gift, yet when I tried the fragrance on, I was immediately uncomfortable. It wasn't a scent I'd wear. Fragrance is powerful. It can evoke feelings of relaxation, comfort, and safety, but can also cause discomfort or irritability. It stimulates our olfactory nerve, and can transport us back to our youth, bring back memories of past loves, or take us back to a less happy time, simply with one whiff.

Fragrance is a personal thing. Sometimes the same fabulous scent you smelled on someone else won't necessarily smell great on you. Your own body chemistry is what makes the scent "work" for you or not. Also, scent is not one-dimensional, but made up of three very distinct layers.

#### Taking Notes

The top note is the part of the fragrance you smell when you first spray it on. The top notes are what usually draw you to a fragrance. You'll know immediately whether you like a specific scent by the top notes. If they turn you off, then you're more likely to not enjoy wearing the scent.

The middle note is the layer of the fragrance that sticks with you during the day. It creates an aura of fragrance, and is usually the part that others around you can smell. If you've ever been complimented on a scent you're wearing, it's usually because those around you are enjoying the middle notes.

The base note is what you're left with after wearing the scent for several hours. It is present at the end of the day, and is usually the faintest hint of the scent you applied first thing in the morning.

#### What to Buy?

Fragrance is available in many forms such as Perfume, Eau de parfum, Eau de toilette, Eau de cologne, and scented body creams. Perfumes have the highest concentration of oils, and therefore last the longest. They are more expensive yet require fewer applications. Colognes and body splashes have a higher alcohol content, so they don't last long, and require more applications.

#### Tips

Layer fragrance with shower gel, body lotion or cream, and cologne or splash in this order.

Don't apply fragrance to clothes or hair. The oil or alcohol in the fragrance can discolor clothing. You want the fragrance to react with your skin anyway. Applying a fragrance with high alcohol content can be drying to hair.

The more we wear a fragrance, the more our noses get used to it, until we don't smell it as well anymore. Don't over apply fragrance; remember that others experience our scent, too.

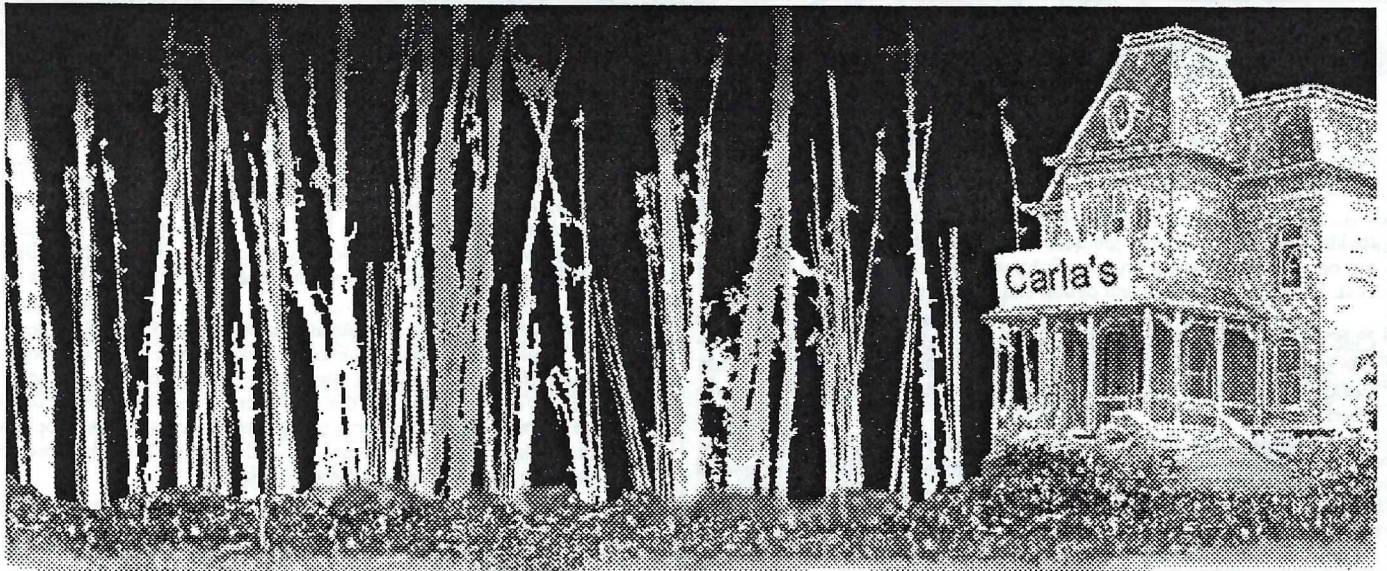

### NTAC Sets Lobby Days for May 2005

Transgender activists will converge on Capitol Hill on **May 18 - 20, 2005** to lobby Congress once again for passage of transgender-inclusive hate crimes and employment nondiscrimination legislation. Lobby Days 2005 is sponsored by the National Transgender Advocacy Coalition (NTAC), the country's largest and most active organization advocating for the rights of transgender Americans at federal, state, and local levels.

Participants are expected from all over the country and will likely include victims of anti-transgender hate crimes and those who have personal experience with employment and other types of transgender bias and discrimination. NTAC and the National Center for Transgender Equality will help attendees arrange meetings with their senators and representatives and staff members.

Marisa Richmond, Chair of the NTAC Lobbying Committee, noted that 30 lobbyists from around the country visited 81 Senate offices and 236 House offices in April 2004 to discuss the need for transgender inclusion in pending civil rights legislation. "This effort played an important role in identifying potential supporters of transgender inclusion in ENDA and LLEEA," she said. "This information was vital to the coordinated effort by transactivists in getting HRC to adopt a new trans-inclusive policy towards ENDA. We look forward to maintaining the momentum in 2005."

One major difference in the 2005 lobbying effort is the recent decision of the Human Rights Campaign decision to support only a transgender-inclusive Employment Nondiscrimination Act (ENDA). It is essential to have demonstrably significant numbers of concerned community activists and supporters working together to educate their elected representatives on these vital issues. The need has never been greater, and HRC support can improve our reception in Congress.

### TRANSGENDER DAY OF REMEMBRANCE

**6th Annual Event will be held  
November 20, 2004**

SAN FRANCISCO, June 16, 2004 - The 6th Annual Transgender Day of Remembrance has been set for November 20th, 2004, with over 100 separate observances expected world-wide. "Since last year's event, nine more people have died due to anti-transgender violence," said Ethan St. Pierre of the Remembering Our Dead project. "So yet again, we will be making it known that such killings are unacceptable.

The most recent reported case of anti-transgender violence leading to death is that of Cedric Thomas of Baton Rouge, Louisiana, who was shot multiple times on May 18th. Thomas died from those wounds on June 5th.

The Day of Remembrance began in 1999 as a way to draw attention to the issue of anti-transgender violence in the wake of unsolved murders such as that of Rita Hester. Hester was killed November 28th, 1995. Her death remains unsolved.

Unlike the murder of Rita Hester, many recent cases — including the rash of Washington, D.C. attacks that left two dead last August — show an increased vigilance on the part of law enforcement and the media to treat these crimes equally. "That we're seeing more stories about these cases, more arrests, and more convictions says that our actions are being taken seriously," said Transgender Day of Remembrance founder Gwen Smith. "yet there is still so much more to do."

Last year's event was honored in over one-hundred locations in eight countries.

*The Remembering Our Dead project <[www.rememberingourdead.org](http://www.rememberingourdead.org)> exists to honor individuals murdered as a result of anti-transgender hatred and prejudice, and draw attention to the issue of anti-transgendered violence. Remembering Our Dead is a project of Gender Education and Advocacy, Inc.*

"Since 1999, NTAC has been advocating in support of equality for the transgender community," said Vanessa Edwards Foster, chair and co-founder of NTAC. "We may well be on the edge of a new era for our community, an era of unfettered accomplishment in our fight for civil rights. It's essential that NTAC and the transgender community are distinctly visible and a key part of this effort towards our equality."

NTAC will hold a plenary session for training and assignments on May 18th. The plenary will consist of a brief lobbyist training session, review of handouts to be discussed and left at each office visited, and assignments for May 19th and 20th. Participants will have the opportunity to meet and interact with many transgender and trans-supportive activists and representatives from organizations working toward fully inclusive federal hate crimes and civil rights protections and to participate in other Lobby Days events and actions to be announced.

As done in 2004, NTAC and the Transgender American Veterans Association (TAVA) are coordinating dates for their 2005 Washington, DC spring events. The second TAVA national gathering of transgender veterans, some of whom are also NTAC members, is scheduled to begin after NTAC lobbying ends on May 20. The TAVA event will include visits to veterans memorials on the National Mall and in Arlington, VA.

You can make a difference, for yourself, your family, and your community. Join your brother and sister transgender American activists, veterans, family, friends, and supporters in speaking truth to our leaders and working for a truly equal America for us all. Your support, your voice, and your active participation will make a difference.

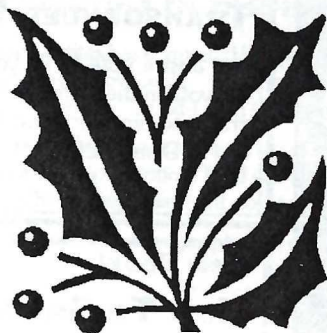

## Important TG Survey: Gender Recognition Act Gender Recognition - An Important Message For All Trans People (Wherever you are based in the world)

Dear All,

Over the past few months, since the Gender Recognition Act was given Royal Assent, Gender Trust, Press for Change and FtM Network have been in close discussions with The Department for Constitutional Affairs (DCA) about implementation of The Act.

The DCA are assessing the Gender Recognition process to ensure that it works as efficiently as possible. In particular, they have been mapping out how the applications are processed to see where potential delays in the system may occur due to a backlog of applications building up at any stage in the process.

One of the key decisions which need to be taken is how many staff will be needed to deal with applications and how long the anticipated early surge will last and what type of applications are likely to be received.

For example 3000 applications in the first month of which half are from overseas applicants would cause serious delays if the expected rate was only 1000 UK applicants.

We need your help to ensure that DCA can match the resources of the Panels and supporting Secretariat to the demand. We as community groups in conjunction with DCA have put together a simple online form which we request that as many of you as possible complete. THE FORM WILL REMAIN ONLINE UNTIL 10 OCTOBER. The Survey Form can be located at: [http://www.gendertrust.org.uk/dca\\_survey.php](http://www.gendertrust.org.uk/dca_survey.php)

The first page of the form explains the background to the survey. Let me reassure you that no personal information will be collected or passed on to DCA - only the basic statistical summary of the eight questions asked will be provided to them.

## TRANVESTITES GO DOWN FIGHTING IN ELEPHANT POLO MATCH

An elephant polo team made up of transvestites has competed in a prestigious tournament in Thailand. The Screwless Tuskers put up a brave show before going down 2-0 to the DBS Bank Ladies. They played on the final day of the 14-team round-robin tournament in the annual event.

Elephant polo - a slower, heavier game than the equine version - is a serious business in Thailand. "It is almost like horse polo but in a very slow motion. But I can tell you it is much more difficult," said Raj Kalaan, a member of the Chivas Regal elephant polo team.

Some 55 players, including three former All Blacks rugby players, gathered in the Thai beach resort town of Hua Hin for the tournament.

### Abubakar Hamza Has Become A Big Celebrity In Northern Nigeria

A transvestite faces trial in September in a case which has become a big talking point in the northern Nigerian city of Kano. The issue of sexual orientation is a controversial one in Africa and the existence of transvestites usually gets little attention. But 19-year-old Abubakar Hamza has become famous with posters of him dressed in women's clothes selling well among male admirers.

He is charged with living and dressing as a woman in the first case of its kind in this conservative city. But what is shocking for many Nigerians is that he lived as a young woman in the heart of a family for seven years, without his secret being suspected.

#### Betrayal

The Adamu family, who have now themselves become celebrities in Kano, were shocked when they discovered Hamza was a transvestite. Until his arrest they fondly called him Kawajo which in the Fulani language means friend.

The mother, Hajiya, says she treated him like her own teenage daughters. "In fact whenever they quarreled I always took his side because I never liked seeing him upset. I was so fond of him he was just like a daughter," she says.

During his stay with the family, Hamza spent a lot of time with her teenage daughters but they did not suspect he was not a girl, despite the fact that he always dressed and undressed in the bathroom. "He never allowed people to touch him in a playful manner," says teenager Umma.

Alhaji Adamu, whom I met sitting in front of his house, told me that even though Hamza had not engaged in any indecent behavior he still deserved to be punished "because he had broken Islamic laws".

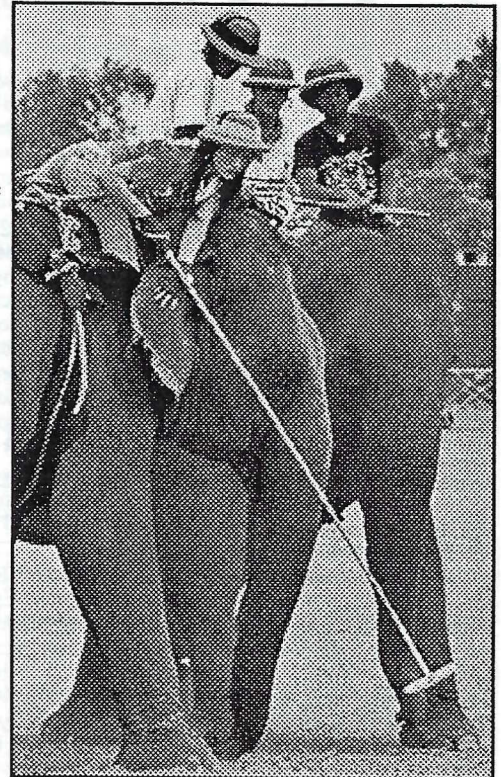
Abubakar Hamza is currently in Kano Central Prison awaiting trial where he will answer charges under Section 9 of the Prostitution and Immoral Acts Law. If he is found guilty he will get either one-year in prison or be asked to pay a fine equivalent to \$80.

Many in Kano are talking about this story and are eagerly awaiting for the trial due on 16 September - if only to get a glimpse of the famous young transvestite.

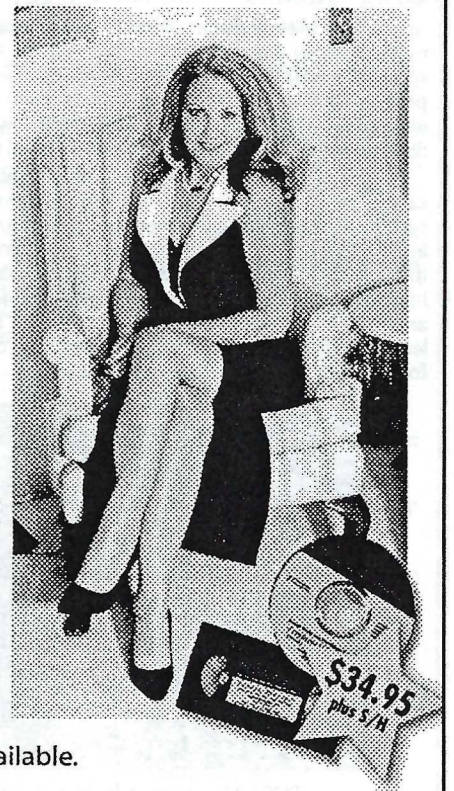

## POLICE TO RAIN ON DRAG QUEENS' PARADE

The gay community is up in arms after a newspaper reported on Wednesday that drag queens will not be allowed to participate in this year's Gay and Lesbian Pride parade in Johannesburg. Furthermore, several businesspeople claim they are still owed money from last year's Pride festival, and a top advertising agency dropped the Pride publicity campaign for this year due to non-payment.

The parade, (which took place on September 25), forms part of a yearly week of celebrations — the biggest of its kind in South Africa. According to *The Citizen*, authorities are citing the Regulation of Gatherings Act, which prohibits any person participating in a gathering, march or protest from wearing a disguise or mask that obscures facial features and therefore prevents identification. The report quotes Johannesburg Metro Police spokesperson Wayne Minnaar as saying the decision was taken to ensure consistency and that no one in disguise or wearing a mask will be allowed to take part in the march. This includes drag queens, because of their wigs and make-up.

In a statement sent to the Mail & Guardian Online late on Wednesday, the Equality Project said this law would also allow police to arrest rugby supporters with painted faces.

The statement says the Lesbian and Gay Equality Project, Pretoria's OUT, Johannesburg's Forum for the Empowerment of Women, Cape Town's Triangle Project and the Durban Lesbian and Gay Health Centre have all stated that the interpretation by police of the Act is "blatantly unconstitutional as it unjustifiably limits a whole host of rights" and that the Act's "purpose is to prevent individuals in a protest action being involved in criminal activity by concealing their identity". "It is quite apparent that [the Act] should be interpreted in the light of a decade of democracy and when read with the Constitution," says the statement.

"The police are required to apply their mind when interpreting laws of this nature, as well as our Constitution, which is founded on fundamental values of human dignity, the achievement of equality and the advancement of human rights and freedoms and which supersedes this Regulation of Gatherings Act, and was promulgated even before South Africans achieved their freedom in 1994," Knoesen added.

### Drag Queens 'Pose No Threat'

"Drag queens are an intrinsic part of our subculture and are a more visible and vocal element, and it is for this reason that many spectators actually attend the Lesbian and Gay Pride march. They pose no threat to society, and in fact many of them are full-time entertainers and enjoy a large and loyal following," said Dawie Nel, director of OUT — a lesbian, gay and bisexual wellness organization.

Wendy Isaacks, legal adviser of the Equality Project, said: "The safety, security and fundamental human rights of members of our community will not be compromised or undermined in any way during this year's Pride march, or at any other time." Isaacks added that the Equality Project is "involved in dialogue with the mayor's office to highlight the futility and inherent attack on basic human rights such as an action by the metro police would signify". "Discrimination against lesbian and gay people violates the principles of equality and respect for inherent human dignity," said Knoesen.

## Appeals Court Overturns Deportation Order Of Tortured Transsexual

(Los Angeles, California) A preoperative transsexual who fled El Salvador after she was beaten and raped was given a reprieve Tuesday from deportation. The Ninth U.S. Circuit Court of Appeals ruled that the woman, identified only in court documents by her male birth name as Luis Reyes-Reyes, was wrongly denied relief under the Convention Against Torture by an immigration judge.

Reyes has dressed and acted as a woman for the past 16 years. In her application for asylum in the US she told the immigration hearing she had been kidnapped, raped and beaten by a group of men because of her sexuality when he was 13 and living with her family in San Salvador. The attackers, she said, threatened reprisal if she reported the incident, and she never told either the authorities or his family. At the age of 17, she fled to the United States.

At her deportation hearing the immigration judge ruled that because she had claimed the attacks against her were by agents of the El Salvador government she could not claim asylum. Judge M. Margaret McKeown said that the immigration judge erred in not applying the full standard of the convention, which includes acts committed "by or at the instigation of or with the consent or acquiescence of a public official or other person acting in an official capacity." "By rejecting Reyes's petition because [she] had 'failed to state that anyone in the government or acting on behalf of the government tortured him,' the IJ effectively excised the phrase 'or with the consent or acquiescence of' from the regulation," she said in her ruling.

McKeown pointed to published reports of abuse throughout much of Latin America of abuse of the transgendered [sic] and gays. But, she also noted that Reyes had filed her application of asylum late, more than a year after her arrival in the country.

Judge Charles R. Breyer concurred, but Judge Jay S. Bybee agreed only with regard to the asylum claim and in the judgment. The case returns to immigration court, but because of the late filing in the asylum application, Reyes could still be deported.

In a letter to NCTE, LLEGÓ, The National Latina/o Lesbian, Gay, Bisexual and Transgender Organization, announced its support for inclusion of transgender people in all future federal legislation. According to LLEGÓ Interim Executive Director Gloria Nieto, "we will not support any federal legislation that does not explicitly include protections for transgender people."

LLEGÓ becomes the 14th national organization to take this position, joining BiNet USA, DignityUSA, Family Pride Coalition, Human Rights Campaign, National Center for Lesbian Rights, National Coalition of Anti-Violence Programs, National Gay and Lesbian Task Force, National Organization for Women, National Youth Advocacy Coalition, PFLAG, Pride at Work, National Stonewall Democrats and the United States Student Association. Many state and local LGBT organizations have also taken this important stand.

NCTE Executive Director Mara Keisling noted, "LLEGÓ has been a very important ally for NCTE and we are thrilled that they have taken this additional step of adopting an inclusion policy. LLEGÓ's support will help tremendously when we talk to Congress next year about introducing more comprehensive legislation."

Keisling added, "LLEGÓ's new Interim Executive Director, Gloria Nieto, has long been a personal supporter of transgender people. NCTE worked with Gloria on inclusive anti-discrimination and hate crime laws that passed in New Mexico in 2003. We are very excited to be working with her at the national level now."

Other LGBT organizations are currently considering taking this solidarity position and NCTE looks forward to this increased support.

## Transgender People Face Extra Security Hassles

### IT ISN'T EASY TO CHANGE NAME, SEX

LOS ANGELES - Looking for the right name, Luca Brenna scoured baby books for months. Jennifer, Sandra, Vanessa. None of them fit. But with a few strokes of mascara and some dabs of blush, the choice of name became obvious. In the mirror, he saw a woman with flawless skin, blond hair, deep blue eyes and thin red lips.

Brenna knew it was time to change his name and sex on his driver's license. So on Dec. 26, 2002, he became Sonya. "It was hard to decide," the 33-year-old said. "How does a name match a person? It's just something about that name that's very connected to who you are."

To many transgender people — those men and women who, gay or straight, identify with the opposite sex — changing their name and gender on official records is as important to their identity as surgery or hormone therapy, advocates say. Since Brenna was a teenager, she knew she was not supposed to be a boy. The name change was a crucial part of a long journey to become what she felt she was meant to be — a woman.

#### Identity Theft Problem

"It meant the world to me," Brenna said of the license with her new name. "I'm somebody. I see myself in that printed ID and it's just the world."

But without an official name change, transgender people cannot use the new name on leases, credit cards, insurance records or college transcripts. And the steps required to change the basic documents — Social Security cards, driver's licenses and passports — can be confusing and sometimes unfair, advocates said.

The increasing concerns of identity theft have made name-change processes for transgender people even more difficult to undertake, attorneys said. "Identity theft is a very real and growing problem," said Michael Hernandez, an attorney who helps transgender people with name changes. "I don't think anybody really gave much thought about how it impacted the transgender community."

For transgender people, the process of changing one's name — which varies from agency to agency — is more complicated because they must change both their name and sex.

#### Advocates Say The Policies Are Insensitive.

"I don't think it's the confusion that frustrates people — it's the injustice that frustrates people," said Christopher Daley of the San Francisco-based Transgender Law Center. "It's complicated not because there are different policies, it's complicated because many policies are operating from a place of ignorance."

But government officials said their policies are in place to prevent identity theft. The California Department of Motor Vehicles allows transgender people to change their name and sex designation using a one-page form that must be signed by a physician. No sexual reassignment surgery is required. The federal Social Security Administration, however, requires proof of surgery before altering records. The State Department needs a court order before it will change a name and sex designation on a passport.

"It goes back to security," said Kelly Shannon, a spokeswoman for the Bureau of Consular Affairs, which is in charge of issuing passports. "We want some legal recognition that this person is the person who they say they are."

## THUMBS UP FOR POLICY ON TRANSVESTITES, TRANSEXUALS

KUALA LUMPUR Sept 15 - The move by the government to understand transsexuals and transvestites and draw up a policy on them is welcomed by the public and this "different" group in the community.

"They should be respected and acknowledged as normal human beings because despite the fact that they are physically and mentally different, underneath it all, they are the same, we are all human," said lecturer Adrian Yao told Bernama in a random survey of views from the people.

The lecturer in a private institution of higher learning here said transsexuals and transvestites are normally harmless and only a minority of them are involved in immoral activities. "I think they have a right to earn respect from society," he said. However, he admitted that Asian society, including Malaysia, is not as open to the concept of transsexuality and cross-gender issues compared with Western countries.

On Tuesday, Women, Family and Community Development Minister, Datuk Seri Shahrizat Abdul Jalil told the Dewan Rakyat that her ministry was gathering information on transsexuals and transvestites before drawing up a policy and actions to be taken on the matter.

Azlan, otherwise called "Nina", a cross-dresser, applauded the proposal to gather information and consult transsexuals and transvestites in drawing up a policy on this matter. A psychology graduate from a local public university, he said it is high time for the country to acknowledge people like himself and conduct a comprehensive study on the matter. "This is a good step. It's better for people to know the statistics and that we are not all bad. It cannot be denied that there are some who spoiled our image but there are also those who hold degrees, are professionals and successful," he said.

He called for justice in keeping with human rights principles and hoped that the policy to be drawn up would open the people's mind and correct the derogatory views of the community towards people like him. "We are also human. I am surprised when prospective employers at job interviews I attended looked oddly at me. This is discrimination. We are not as open-minded as compared with other countries ... it's unfair if we look at a person without assessing their capabilities," he said.

From a religious point of view, a committee member of a local religious organization who preferred anonymity agreed with the minister that the problem is complex. The mother of two said while this group of people should exert their basic human rights, most mainstream religions opined that they should maintain their gender given from birth. "From a religious point of view, I think I would say yes and no (the justification of the nature of this group). Yes, because they are physically God-created, there is no such thing as man being a woman or woman being a man.

"I always believe the tendency to deviate to transsexuality or transvestism is caused by the environment factor, the way they were brought up. I don't believe it is part of genetics," she said. She however said the public should show compassion to such people as they were like everyone else; trying to find a place in society and, perhaps, gaining attention and acknowledgement by behaving the way they do.

## LISA-LEE ALBUM LAUNCH

A soprano who did not discover she was a woman until she was 19 is preparing to release her debut album. Because of a rare medical condition Lisa-Lee Dark, from Swansea, thought she was a boy. Despite being a pupil at an all-boys comprehensive school, she only discovered her true gender after she left and doctors diagnosed congenital adrenal hyperplasia (CAH). But her condition and singing may be related.

The testosterone-boosting treatment she took in her teens could be the reason her voice is able to span eight octaves, she said. Now 27, Lisa-Lee will launch her debut album *Breath of Life* next month.

"It's what I would class as an easy listening, classical chillout album," she said. "Two or three of the songs are really well know. The others are not as well known."

In females the excess of testosterone that people with CAH have can cause abnormal genital development before birth. CAH sufferers are often spotted through the low level of salt in the body, linked to a hormone called aldosterone.

"Nowadays most people are spotted, so if you've got a salt deficiency it's picked up early in life, but I didn't have that. But they don't screen for CAH so people still fall through the net. People are more aware of it, but even now you still come across doctors who are not familiar with it at all. It doesn't just affect female babies, it can happen the other way around.

"I went to see a specialist when I was about 15 who gave me the wrong diagnosis. He told me I had a rare hermaphrodite condition and said my body was trying to become female. So I took a lot of male hormones to try and make myself more male."

Lisa-Lee has now accepted the diagnosis of CAH and her true gender. Named Lee at birth, she changed her name in her twenties, choosing Lisa to prove she was not intimidated by bullies who taunted her with the name for being so feminine at school.

## QUEENS WILL GET CHANCE TO WALK WITH PRIDE

Drag queens were most welcome at Johannesburg's 15th gay pride march next weekend, despite media rumors to the contrary, the organizers said on Friday. "Pride 2004 is open to all who wish to attend. Drag queens are an intrinsic part of the gay community and we stand by our constitutional right of freedom of expression," said Sean Lucas, promoter of the event.

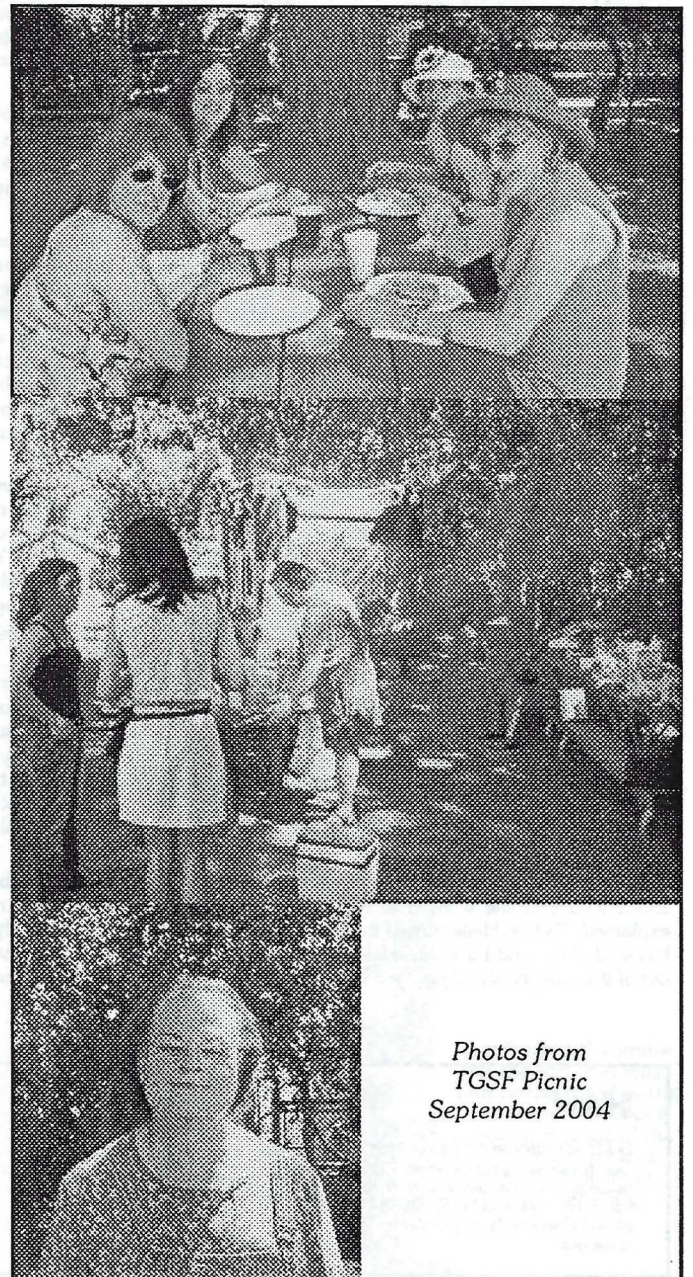
Pride 2004 would take place as scheduled on September 25 with the approval of the police, said event organizer Gary Bath. Metro police had earlier said that drag queens would be prevented from marching, because it is illegal to disguise one's appearance at a public gathering.

While Metro police spokesperson Wayne Minnaar would not confirm to Sapa that they had changed their attitude, he said there would be an "amicable solution so the march can go ahead". He said a meeting was scheduled for Monday to confirm all conditions of marching.

This week South Africa's lesbian, gay, bisexual, transgendered [sic] and intersex community voiced its outrage at the news that drag queens at the event would be arrested.

It was not only the drag queens who were affected, said Dawie Nel, the director of Out, a health organization of lesbians, gays, bisexuals, and transsexuals. "Drag queens are the reason that many spectators actually attend the Lesbian and Gay Pride march. Many of them are full time entertainers and enjoy a large and loyal following."

## OPRAH WINFREY: AGENT OF MORAL INSANITY

*[Editor's Note: I picked-up this insidiously slanted article from what's being published by the ultra-conservative religious right, in an attempt to expose you to what we're up against.]*

Oprah Winfrey, widely cited as one of the most influential and admired women in America, showed herself to be an agent of moral insanity when she featured a program celebrating young children who are seeking sex-change procedures and transgender identities. In one episode of "The Oprah Winfrey Show," the true nature of our modern sexual confusion was made clear, and the broadcast should long be remembered as one of the most frightening hours in television history.

The program, broadcast on Tuesday, August 24, began with Oprah introducing the children seeking a sex change. "This is going to be a very fascinating show, OK?" Oprah began. She then introduced her first young guest: "He is an 11-year-old child. He likes skateboarding and PlayStation. He listens to rap, studies hard, gets good grades and wears those trendy baggy pants. He was also born a girl."

Oprah then moved to the broader theme of her program. "And right now according to experts, there are thousands of children who are living what appear to be very normal lives but deep inside they know something is terribly wrong or they feel that something is terribly wrong, and these children are saying that they were born in the wrong bodies. Their parents have to decide whether or not to let their children live as the opposite sex. Eleven-year-old Kayla lived for years with this secret."

According to a video broadcast on the program, Kayla was born a girl in 1992, but her mother reported that "Kayla never played with girls' toys, never played with dolls. About two years of age on, Kayla was more into dirt and bikes...she would pick out baggy pants, boxer underwear. She didn't like girls' underpants."

At some point, Kayla saw an episode of the Oprah show and was prompted to declare that she was now a boy. She told her mother that she believed she was a boy born into a girl's body. Her mother Angelina responded in a way that left Oprah nodding in approval. "My first reaction was basically blowing it off. A few days later, I said, 'OK, let's find out more about it.'" As the show unfolded, the audience was told that Kayla, now "Kaden," was facing struggles at school. Early puberty presented additional challenges, so Angelina put her 11-year-old daughter on Depo-Provera. Kaden told Oprah's audience, "When I'm old enough to, I want to get testosterone and my surgery."

The next child featured on Oprah was Dylan, a boy who at age four declared that he wanted to become a girl. Now, a couple of years later, Dylan is even more certain that he wants to be a girl. Dylan's mom shared that this has become something of a stress point in the family. "Dylan's dad has a real hard time accepting this. He'll reprimand him." As Oprah continued the questioning, it turned out that Dylan's mom has been buying him dolls and painting his fingernails. Dylan's dad, Derek, is indeed having "a real hard time accepting this."

After a conversation with a "transgender therapist," Winfrey then confronted Derek with his refusal to go along with his son's desire for a sex change. Coming out of a commercial break, Oprah told her audience: "And as I—I was saying to Derek during the commercial break, I was saying that this is your holiest hour. This will be your holiest hour as a parent, being able to allow your son to be himself and to love him as he is. Whatever that turns out to be, you know, that's where, where you will be challenged emotionally, spiritually and otherwise, I think."

Oprah's third young guest was Halle, a young girl who at age six announced that she wanted to be a boy. As Karen, the child's mother, explained, "When Halle turned three, she said she wanted to be a boy. My husband, Eric, and I thought Halle was just a tomboy, maybe she'd grow out of this, maybe she'd just be a lesbian. Then Halle began to act out. She

became verbally abusive and was extremely depressed. At one point, Halle said to me, 'I'm not meant to be here, Mama. It would be easier if I were in heaven.' Halle was six at the time. We started to see a therapist. She told us Halle was transgender. When we discovered what transgender meant, we were devastated. We felt like we were losing our little girl. Halle told us to call her Hal. When Halle turned seven, we began to let her live full-time as a boy. At school, he told his friends that he had a boy's heart and a girl's body. Even though I miss my daughter, I am so lucky to see my son happy." "Hal's" parents are very broad-minded about their child's sexual and gender exploration. Looking to the future, "Hal's" mother commented: "He knows his options. He knows about blockers and he knows about the hormones, but those are things that he absolutely has to come to terms with and he has to make those decisions. We support him whichever way he chooses to go. And we've always supported that. We've always said, you know, 'We understand you are a boy inside. You feel like a boy, but if you ever change your mind, you just tell us and we will support you,' because we don't want him to feel like he's got to be one way or the other."

After all this, Winfrey celebrated what she called an "evolution" in social tolerance and cultural acceptance of the idea of a sex change, even among children. "I have seen such a change in the way parents parent, you know," Oprah declared, "even in the years that we've been here, 18 years, seeing such a difference—this generation, your generation, is so much more open to accepting children as they are instead of trying to—forcing whatever your own idea was."

This isn't "evolution," this is insanity. Oprah and her guests were involved in an absurd and horrific exercise in moral inanity. What culture can survive such a rebellion against the moral order? What devastation and destruction will be brought into the lives of young children before some level of sanity is reestablished?

The ideology of the homosexual movement has been subverting the reality of gender for decades. The very fact that human beings are created as male and female flies in the face of the utter rebellion against and rejection of the moral order that stands at the very center of the homosexual agenda.

Instead of helping these young children to grow into maturity as the boys and girls they were meant to be, growing into womanhood and manhood with the assistance and moral direction of parents and other authorities in the society, these children are encouraged to "explore" their gender and sexuality in order to determine who they really are. The very idea that we "discover" our gender as a matter of interiority is itself an act of aggression against the moral order and a demonstration of human arrogance against the divine design of creation.

The postmodern enablers of the homosexual movement and its transgender wing have convinced the cultural elite that gender is merely a matter of social construction and biological accident. Sexual and gender "identity," we are now told, is simply a matter of coming to terms with the self and its own orientation. Gender is now a plastic reality, moldable and changeable throughout one's lifetime. Oprah, joining the insanity as an agent of moral revolution, brought on a guest introduced as a gender therapist to clarify the issues. Explaining Dylan's situation to his father, therapist Jana Ekdahl told Derek, "Dylan feels that he's in the wrong body. Dylan wants to be a little girl. And there's really nothing that you can do to change that nor is there anything that you've done to cause that. Frequently parents, especially mothers, feel that they've done something to cause it, but that's just not true." Oprah Winfrey, ever the scientific expert, asked, "It occurs in the womb, does it not?" Ekdahl responded with assurance that gender orientation "does occur in the womb." She went on to suggest, "The research so—so far shows that it occurs in the first trimester." As she explained, "Something happens, whereas the brain develops in one direction and the body develops in another. For instance, for Dylan, it might be that his body was developing as a boy, whereas his brain was developing as a girl. Then he comes out, and he looks like a boy. So it's much easier to change the body. We can't change the brain."

But this isn't medicine at all—it's more like therapeutic voodoo. Jana L. Ekdahl, the therapist featured on the Oprah program is, according to her own website, a psychotherapist who "welcomes the transgender population." As she explains, "The youth of today are indeed our future. I have had the rare privilege of meeting and working with gender-variant youth. They are changing the face of gender for us all. I sometimes view them as archetypal warriors on the cutting edge of that space between the two polarities that we hold onto so tightly. Perhaps it would serve us all to go to that place . . . that special space between genders . . . and see what we find there."

What we find there is an absolute moral meltdown. The very notion that we should see young children suffering this level of sexual confusion as "archetypal warriors on the cutting edge" of gender development is insidious, tragic, and should be scandalous. Ms. Ekdahl's agenda is made clear when she suggests that it would "serve us all to go to that place."

## Title VII Decision

# FEDERAL APPEALS COURT ALLOWS SEX DISCRIMINATION CLAIM BY TRANSEXUAL

[Editor's Note: I gleaned this from the monthly California Employment Law Newsletter we subscribe to at my office.]

In a decision that's sure to send shock waves through human resources departments across the country, the Sixth Circuit has allowed a transsexual firefighter to pursue sex discrimination claims against his employer under Title VII. This is the first time a federal appeals court has recognized such a claim. Let's take a look at this fascinating court decision and what it may mean for you.

### Facts

Jimmie Smith had been a lieutenant in the Salem, Ohio, Fire Department for seven years when he was diagnosed with gender identity disorder (GID), or transsexualism. That basically means he's biologically a man but his sexual identity is that of a woman. Part of the treatment for people with GID is that they start dressing and acting like the sex they believe they are. That often leads ultimately to a sex-change operation.

Smith's lawsuit alleged the following facts. When, after seven years with the department, he began dressing and acting more feminine at work, the other firefighters questioned him and commented on his waning masculinity. As a result, he decided to talk to his supervisor, Thomas Eastek, about his condition. He told Eastek that, eventually, he would probably undergo a sex-change operation. Smith's sole purpose in talking to Eastek was to explain the changes in his appearance and demeanor so that Eastek could address the matter with the other firefighters.

Eastek told the city's fire chief about Smith's condition and behavior after promising not to. The fire chief responded by, together with the city's attorney, devising a plan to get rid of Smith. Apparently afraid to fire him outright, they decided instead to require him to undergo three psychological evaluations with physicians of their choosing. They apparently hoped that Smith would either quit (rather than submit to the evaluations) or refuse to comply (in which case they could fire him for insubordination).

Smith found out about the plan, got a lawyer, and filed a complaint with the EEOC. A few days later, the city suspended him for allegedly violating a city regulation. That suspension was eventually overturned by a court because the regulation Smith supposedly violated wasn't in effect at the time. Smith apparently still worked for the fire department throughout the duration of his lawsuit and appeal.

Because GID is a recognized medical condition, you might wonder why Smith didn't sue for disability discrimination under the Americans with Disabilities Act (ADA). The answer is that the ADA specifically says that it doesn't apply to transsexualism. We assume that Smith didn't pursue a harassment claim because the comments of his fellow firefighters didn't rise to the level of a hostile work environment.

### Legal Claims

To understand the court's decision, you need a little bit of background. As you know, Title VII prohibits discrimination in employment on the basis of sex. What that means exactly has long been the subject of controversy and dispute. The U.S. Supreme Court hasn't issued all that many decisions on the subject of sex discrimination, but when it does, it tends to be a doozy.

Such was the case in 1989, when the Court issued its decision in *Price Waterhouse v. Hopkins*. In that case, one of the accounting firm's senior managers was turned down for partnership because, in part, she was considered "macho." She was told that if she wanted to improve her chances for partnership, she should go to charm school; walk, talk, and dress more femininely; and wear makeup and jewelry.

The Court said that denying a promotion to a woman because she's not "feminine enough" is sex discrimination. Since that decision, the courts have generally recognized federal law claims for "sex stereotyping" — or discrimination against a woman because she fails to "act like" a woman.

Smith argued that that's essentially what happened to him. The city discriminated against him because he failed to act like a man. In 1983, the Court recognized (in a case that didn't involve sex stereotyping) that Title VII prohibits sex discrimination against men. It follows, then, that if employers can't discriminate against women who aren't feminine enough, they can't discriminate against men who aren't masculine enough, either.

The trial judge basically thought that Smith was trying to disguise what was essentially a claim for transsexual discrimination as a claim for sex stereotyping. But the appellate court disagreed, saying that it could see no difference between Smith's situation and that of the "macho" female manager in the *Price Waterhouse* case.

But the Sixth Circuit went even further, concluding that Title VII prohibits discrimination not only on the basis of a person's actions (a man acting like a woman) but also on the mere fact that the person is a transsexual (even if the person doesn't "act like a member of the opposite sex). A man who professes to be a transsexual, the court explained, is inherently stating that he wants to be a woman, and that's the same thing as acting like a woman under the theory of "sex stereotyping." *Smith v. City of Salem, Ohio* (6th Cir. 2004).

### Bottom Line

Perhaps the biggest question this case raises is what impact it will have on the ability of homosexual employees to sue in federal court for sex discrimination. It has long been acknowledged that Title VII doesn't prohibit harassment or discrimination on the basis of an employee's sexual orientation. Not all homosexuals exhibit behavior or mannerisms that resemble those of the opposite sex. In other words, not all gay men are effeminate, and not all lesbians are masculine. It seems clear, then, that employees who are discriminated against or harassed solely because of their homosexuality wouldn't be able to assert a claim under Title VII. But if a homosexual doesn't conform to society's rules regarding appropriate masculine or feminine behavior, it appears that he or she would be able to sue for sex discrimination under the theory espoused in this case.

The good news is that the chances that you will have a transsexual employee are pretty slim. The bad news is that if you do have a transsexual employee, it's no longer clear what your legal obligations are. Our best advice is to follow the golden rule of employment discrimination:

Evaluate employees on the basis of their job performance, not on irrelevant personal factors such as their sexual identity or orientation.

Staffed by caring and committed transgender and gender variant people, TRANS provides an informal drop-in center where MTF and FTM transgender people, gender queer and gender variant people can go to relax, socialize, take a shower, and join in the ongoing effort to foster the well-being of our community.

## Gwen Amber Rose Araujo (1985 - 2002)

...A transgender teenager from Newark, CA was murdered at a party by a group of men upon discovery of her transgender status. Twenty months after Gwen Araujo's death the jury deadlocked on whether her attackers were guilty of first or second-degree murder. According to Alameda County District Attorney's Office, none of the jurors were willing to settle for the lesser offense of manslaughter — despite efforts by defense attorneys in the case to argue that Gwen's killers were somehow justified because she did not disclose her transgender identity to them. The prosecutor already has stated that he will re-try the three defendants, Michael Magidson, Jose Merel, and Jason Cazares, for murder.

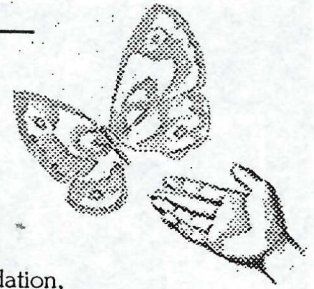

Oprah interviewed Ms. Ekdahl as if she represented the medical establishment, but her own website identifies her education as including baccalaureate and master's degrees in psychology, and certification from the State of Washington as a Licensed Mental Health Counselor and a Certified Sexual Minority Specialist—whatever that is. As she shares with her perspective clients, "I embrace the philosophy of Carl Jung and Depth Psychology. The union of East and West is essential to my work, as I have studied to learn about the modalities of each. Buddhist thought and Native American spirituality are interwoven into the fabric of my psyche. I have access to this wisdom to share with my clients, either directly or otherwise."

Is this where we are headed? Oprah Winfrey did not merely feature the subject of children struggling with their identities, she chided the parents who would not go along with this "evolution" in moral consciousness and, as she warned one parent, "And what do you think will happen if you remain as closed as you are? What damage will be done by you not opening up to who he really is?"

In reality, that father was the only adult to appear on that program with the slightest degree of common sense and moral wisdom. Yet, he was the one blamed for wanting to limit his child's self-exploration and gender transformation.

America learned a lot last Tuesday. We learned that we are in much deeper trouble than most Americans could ever have conceived. We learned that the moral revolution pushing a complete transformation of the sexual order has now progressed to the point that our children are being told they should explore their gender identity and, if inclined to do so, change genders. We also learned that Oprah Winfrey has taken sides in this revolution. After Tuesday's show there can remain little doubt that Oprah Winfrey is an agent of moral insanity.
